1. Fire

- a. FEMA dispatch system will be installed by start of 4th quarter
- b. Safety task force update- 19 more "bleed: kits will be purchased
- c. Mr. Puthoff talked about AED stations around the grounds and one unit in the adm. Building, with "bleed' kits with 2-way communication to HC
- d. Lucas device- free trial ran out and trying to get approval for BWC to use the remainder of grant and has a reciprocal agreement with the City of Reading.
- e. Additional grant opportunities- for aging equipment etc. from Firehouse Subs
- f. Ambulance will go on HC auction website
- 2. Police
 - a. Golf cart ordinance Chief Korte went through the golf cart ordinance. GE representation attending the meeting to confirm they are in agreement with the ordinance. Their goal is safety. When they use the road their slow moving vehicle will be escorted. This will be an amendment to the ordinance.
