#### MINUTES Village of Evendale Regular Council Meeting July 14, 2020

# The Village of Evendale Regular Council Meeting was called to order by Mayor Richard Finan at 7:00 pm.

A public hearing was held for the 2021 tax budget. No comments were made and hearing closed.

#### **Reports of Council Committees:**

# Finance, Recreation, CAC Council Committee and Code Enforcement:

Mr. Albrinck reported the VOE was still in a positive financial position. Tax revenue exceeded YTD 2019. The VOE budgets conservative and still on budget. The impact of GE is not known. The recreation department has 142 swimmers and only inter-squad scrimmages. Rentals of pavilions are being rescheduled. GHF is open to the public and planning for Row-by-Row To-Go event. Shred day is July 18. Thru the Valley completion date is moved to November. Decorative railings are currently being installed.

# Police, Fire, Service, Engineering and GHF:

Ms. Smiley Robertson reported the chili lunch is August 12. There have been 9 confirmed cases of COVID in the VOE. Hiring committee for police has interviewed 7 candidates and made offers to 3 candidates. They need to go through physical and phycological testing. VOE will be housing inmates at Sharonville because Butler County was always full. The committee went through the Use of Force policy. VOE policy stands up well to recommended policy. There were no recommendations to change the policy just a reporting issue. CAC is reopened on June 14. Some classes are being held outside. August 14 will be the drive-thru Big Arts party.
