MINUTES Village of Evendale Regular Council Meeting March 12, 2024

The Village of Evendale Regular Council Meeting was called to order by Mayor Richard Finan at 7:00 pm.

Roll call- The following council members were present: Mayor Richard Finan, Council Members: Mr. Patterson, Ms. McDaniel, Mr. Sextro, Mr. Berke, Mr. Puthoff and Ms. Smiley-Robertson. Also present: Village CFO Cynthia Caracci, Village Law Director, Police Chief Tim Holloway, Fire Chief Mike Hauck, Recreation Director Adam Knight, Service Department Director James Jeffers, and Village Clerk, Barb Rohs.

Hamilton County Commissioner, Denise Driehaus, addressed council. A list of opportunities that HC provides was distributed. The Gun Range financing is ready and waiting for the EPA to approve site to move the range. Commissioner Driehaus thanked the mayor for pushing this project. It is a \$32,000,000 project funded by the federal, state, city and county level. The site will be moved to Colerain Twp. and become a regional training complex.

- Spending time on strategic plan at board meetings

- Shelter house floor renovation will start next week
- Concrete wall around sand volleyball is being constructed. This will contain the sand.
- Potential new registration software is being tested with hopes for fall installation
- Egg-Stravaganza is this weekend
- Valentines Dance was successful
- Impact 57 is growing

Service:

- Working on wall surrounding sand volleyball courts
- Sam Asbrook passes ISA Arborist certification course and he will the VOE arborist.
- Shred day is April 20th- 8-noon
- Stantec will start work in Griffin on 3/12
- New planter will be installed on Reading Rd. along with sprinklers
- Phase 3 of rec center is still in progress
- Preliminary plans for CAC for elevator is being worked by architect
- Pricing and rendering of new service building are being finalized. The cost has gone down. Hopes to getting conditional approval at planning commission next week.
- Soon Mr. Jeffers will be evaluating streets for 2024 resurfacing program. He reviews all VOE streets. There will be a stripping program included in the program.

- 14 permits for \$218,000 in building improvement

Mayor Finan reported he attended the ICRC meeting and subscriptions of Alta-fiber and Spectrum continue to decrease. Ohio is doing a 250-year celebration and VOE will tie it into 2026 4th of July celebration
