New Business:

1) Consideration of a possible text amendment to the Village of Evendale Zoning Code pertaining to Mobile Food Service.

Discussion by Tom Underhill owner of Heavenly Hotdogs who wants to rent space from Menards to run his Mobile Food Service.

Discussion by David Elmer re: other businesses in the PUD and how they handle outside tables etc.

Discussion by Kathy Ryan re: current code restrictions on Mobile Food Service.

Motion was made by John Richey and seconded by Mark Ferguson that Kathy Ryan draft the required code revisions to be discussed by the EPC by email over the next month so that it may be presented at the next EPC meeting.

2) Consideration of a possible text amendment to the Village of Evendale Zoning Code pertaining to off street parking and signage.

Discussion by James Jeffers re: updating the off street parking section under 1258.02 so that "All traffic control markings and signage shall meet the provisions of the Ohio Manual of Uniform Traffic Control." (OMUTCD) These provisions are to apply to both public and private roadways for public use. Existing facilities would be grandfathered until future revision.
