OUR MISSION

The members of the Evendale Police Department are committed to the principles that define democracy, including the protection of constitutional rights and equal protection under the law. We will at all times exercise the authority granted to us in an ethical, consistent and lawful manner.

ASSAULT

On 3/2, victim responded to the station reference a report. Victim reported she was at Speedway, 10760 Reading Road. After pumping gas, the victim was sitting in her car and the defendant opened the car door and grabbed the victim by the throat and started choking her. The defendant then left the area. The victim has a protection order against the defendant. Defendant charged with assault and violation of protection order. Case closed by arrest.

On 3/15, officers were dispatched to Walmart for a reported assault. Upon arrival, officers spoke with the complainant and she stated a subject approached her in the store and spit on her. While checking the store for the subject, another victim approached officers and reported a similar offense. Case is under investigation.

THEFT

On 3/1, officers were dispatched to Verizon on Cunningham Drive for a theft report. The store manager reported the suspect entered the store, briefly looked at the display case and then exited the store. Two prepaid phones were missing from the display case. The suspect was confronted by the manager about the phones and entered a red Toyota Corolla on the lot and left. Total value of phones \$348.00. Case remains under investigation.

On 3/3, officers were dispatched to Menards for a theft that just occurred. The complainant reports a man left the store with a cart full of merchandise and did not pay for any of the items. The subject was asked for a receipt and he said he did not have one. The subject then loaded the items into a 1994 red van and left as a passenger in it. Total value of theft \$463.97. Investigation is pending at this time.

On 3/5, officers were dispatched to

Walmart for a theft which had just occurred. The subject was in custody in the Loss Prevention Office. According to LP Williams, the suspect selected items and opened the packages. The suspect then concealed the items and attempted to leave the store without paying. Total value of items \$111.40. Case closed by arrest.

On 3/8, the general manager of Papa John's reports a series of theft offenses by an employee. She slowly woke up and he seemed discovered a series of discrepancies in paperwork by the suspect. The suspect would change the tip amounts on users cards without their authorization and change the total amount due to a lesser amount, and keep the difference. At the time of report, Papa John's has suffered a loss of \$1,000.00. Pending further investigation.

On 3/11, officers were dispatched to 10671 Evendale Drive for a theft from a truck. Once on scene it was discovered multiple trucks had been broken into on the lot. A Garmin GPS Commercial version was missing from the victim's truck. Total value of theft \$499.00. This case and companion cases under investigation.

On 3/15, officers were called to Walmart for the theft of a wallet. The victim stated her wallet had been taken out of her shopping cart while in the infants section of Walmart. The wallet contained her ID card. \$55 cash and multiple cards from businesses. The victim did not have a description of a possible subject. Walmart is gathering video to aid in the investigation. Investigation pending.

On 3/28, officers responded to Subway for an employee theft investigation. Subway manager reports the suspect employee hid their brown dime roll box of \$400 cash under the counter by the cash register and now it is missing. Video surveillance confirms

the suspect hiding the \$400 cash box there. Investigation is pending at this time.

DRUGS

On 3/3, officers were dispatched to Norwood Hardware for a suspicious vehicle. The vehicle was located and the subject in the driver's seat was slumped over the steering wheel. Officers attempted to wake the subject, but he was unresponsive. The subject very out of it and was noticeably impaired. The subject was found to have 93 Xanax pills in his center console. Subject charged with drug possession and transported to HCJC. Case closed by arrest.

On 3/6, officers were dispatched to IR-75 South for an auto accident. Upon arriving on scene, officers observed a subject standing next to a wrecked vehicle. The subject stated he was dropped off to the accident scene to make sure everyone was okay. However, a witness stated she observed the subject crash his vehicle and get out of the car. The subject was found to have a powder substance in a paper bindle on his person. Case is under investigation pending lab results.

MISUSE OF CREDIT CARD

On 3/7, victim came to the station to report his GE Credit Union credit card was compromised. An unknown suspect unlawfully accessed his GE Credit Union credit card account and made point of sale purchases at 4 separate Kroger locations. Victim is still in possession of the physical card. Total amount of charges \$295.19. Case is under investigation.

PROPERTY DAMAGE

On 3/20, officers responded to TWC Concrete for damage caused by a semi attempting to turn around on the restricted area portion of the business property. Case closed exceptional means.
