# EVENDALE POLICE DEPARTMENT COUNCIL REPORT

## FEBRUARY 2017

### OUR MISSION

The members of the Evendale Police Department are committed to the principles that define democracy, including the protection of constitutional rights and equal protection under the law. We will at all times exercise the authority granted to us in an ethical, consistent and lawful manner.

#### ASSAULT

On 2/9, officers responded to Menards for a report of an assault that just happened. Menards General Manager explained that a customer who had just left the store, pushed him against some shopping carts after a heated verbal altercation. Store surveillance video showed events consistent with what the Menards General Manager described. The Manager did not want to pursue criminal charges at this time but wanted the subject banned from the Evendale Menards store. Case closed—suspended inactive.

#### THEFT

On 2/6, officers were called to Walmart for an unidentified subject that left the store in a motorized cart with \$93.83 in various merchandise items that were not paid for. When confronted, the subject abandoned the merchandise in the parking lot and got into the passenger seat of a green Mitsubishi. Case remains under investigation.

On 2/9, officers were dispatched to Walmart for a theft that had just occurred. The female subject concealed \$137.40 worth of merchandise items and fled from Walmart Loss Prevention. The suspect fled the store on foot and left the parking lot in a waiting PT Cruiser. Case suspended pending suspect I.D.

On 2/11, officers were called to Walmart regarding a theft from earlier in the morning. An Assistant Manager observed the suspect load up a cart with beer, sheets and Tide laundry detergent. The suspect made no attempt to pay for the items and pushed the cart out the General Merchandise doors. The suspect was recognized as someone who had been arrested before. Total value of theft \$490.76. Investigation pending.

On 2/18, officers were dispatched to Walmart for a theft report. The suspect was seen opening a Home

Solar Security System package and concealing the items in his jacket and pants. The subject was stopped and transported back to the station for processing. Total value of property \$229.00. Case closed by arrest.

On 2/28, officers were called to Walmart for a shoplifter in the office. The suspect concealed items in her purse and then walked past the last point of sale without making any attempt to pay for the items. The suspect admitted to the theft and was given a court date for Evendale Mayor's Court. Total value of theft \$54.08. Case closed by arrest.

#### DRUGS

On 2/16, officers were called to a car pulled over on the left berm of IR-75. The driver of the car stated there was 'weed' in the vehicle. The driver gave permission to search the car and a baggie of marijuana was located as well as a copper pipe with burned marijuana inside. Both items were seized as evidence and the driver was issued a MM citation for the marijuana. Case closed by arrest.

On 2/18, a vehicle was observed going 88 MPH in a 55 MPH zone. The vehicle was stopped and a strong odor of marijuana was immediately noticed coming from the vehicle. The officer asked where the marijuana was in the vehicle and the driver stated he had a baggie in the center console and a marijuana cigarette in the cup holder. The marijuana was handed over to the officer and the driver was cited to Evendale Mavor's Court and released. Case closed by checks. The subject deposited a arrest.

On 2/26, officers were dispatched to Interstate 75 for an auto accident with injuries. Upon arrival, officers spoke to the suspect that crashed the vehicle. Officers detected a strong odor of marijuana and alcohol in the vehicle. The

driver of the vehicle was administered field sobriety tests and he was placed under arrest. The vehicle was searched and 2 baggies of marijuana were found in the center console. The subject was cited for drug abuse and OVI and released at the station. Case closed by arrest.

#### PASSING BAD CHECKS

On 2/10, the Manager of Sharefax Credit Union came to the station to report a subject had passed bad checks and now had a negative balance. The subject has been contacted via phone and certified letter and he still owes Sharfax \$1503.73. Case under investigation.

On 2/21, GE Credit Union reported a case of passing bad checks. The subject deposited three checks into her GECU account via various ATM's. All three checks were returned unpaid as "Account Closed". The checks were reversed creating a negative balance in the amount of \$4,233.40. The subject was sent a certified letter. but has not remitted the amount due. Case under investigation.

On 2/21, GE Credit Union reported a case of passing bad checks. The subject deposited a check into his account via ATM. The check was returned unpaid as "Non-sufficient Funds". The check was reversed from the account creating a negative balance of \$2534.36. A certified letter was sent. Case under investigation.

On 2/22, GE Credit Union reported another case of passing bad check into his account via remote deposit capture. The check was returned unpaid as "Refer to Maker". The check was reversed from his account creating a negative balance of \$976.68. A certified letter was sent, but the subject has not responded. Case under investigation.
