OUR MISSION

The members of the Evendale Police Department are committed to the principles that define democracy, including the protection of constitutional rights and equal protection under the law. We will at all times exercise the authority granted to us in an ethical, consistent and lawful manner.

BREAKING & ENTERING

On 1/2, while on routine patrol, officers discovered the north side cage of Walmart had been broken into. The cage is used to store tires and batteries. The manager of Walmart confirmed there were batteries taken from the cage, but was unsure of the amount and style of batteries. Case is under investigation.

On 1/15, officers were called to a residence on Glendale-Milford Road for a theft and breaking and entering report. An unknown person(s) made entry into the victim's vehicle in her driveway and removed loose change and candy from the vehicle. The suspect then used the garage door opener to make entry into the garage. Entry was made to another vehicle inside the garage, but nothing was taken. Case suspended inactive pending further investigative leads.

On 1/23, officers responded to Accurate Masonry on Glendale-Milford Road for a break in that occurred overnight. An employee stated that when he arrived that morning, he found multiple structures that had been forced open. An area of the chain link fence had been cut open to gain access to the property. Case is under investigation.

THEFT

On 1/5, officers were called to Uncle Yip's restaurant for trouble with a customer. The suspect had left without paying for her meal valued at \$23.40. The suspect had already left when officers arrived. Employees were unable to get a license plate. Case suspended inactive.

On 1/5, officers responded to Walmart for a shoplifter. The suspect had concealed \$119.18 of clothing and jewelry items in her purse. The suspect passed the last point of sale and made no attempt to pay for the items. Subject cited to Mayor's Court and released. Case

closed by arrest.

On 1/11, officers responded to Walmart for two shoplifters in the LP Office. One subject took \$181.46 worth of merchandise and the other suspect took \$199.50 worth of merchandise. Both suspects were arrested for theft and cited to Evendale Mayor's Court. Case closed by arrests

On 1/13, officers were dispatched to Walmart for a theft in progress. The LP Officer was able to stop the subject and she was found to have \$96.56 in merchandise that was not scanned or paid for. The subject admitted to the theft. Subject cited to Evendale Mayor's Court and released.

On 1/14, officers were called to Sports Plus for a broken rear window of a vehicle in the parking lot. Further inspection showed that the victim's wallet was missing and his briefcase containing his work issued laptop computer. Case suspended inactive.

On 1/19, officers responded to Menards for a theft that just occurred. The suspect fled the scene in a black Honda. The suspect was stopped by a Hamilton County Sheriff's Deputy on patrol in the area. Officers responded to the traffic stop and arrested the suspect for theft and obstructing official business. Total value of stolen merchandise \$769.84.

On 1/23, officers were called to Walmart for the theft of a purse. The victim stated she dropped her purse while exiting the store to the parking lot. Walmart video shows a red Toyota Sienna with unknown occupants pick up the purse and exit the parking lot. Video was not good enough quality to get a license plate. Case suspended inactive pending any new leads.

On 1/26, officers were dispatched to Menards for a theft that just

occurred. The suspect had jumped into a van heading towards Reading Road. The van was not located in the area and officers responded to Menards for follow up. The suspect took a nail gun valued at \$149.99. Case is under investigation.

MENACING

On 1/1, victim reported to the station and advised her exboyfriend threatened her while at a group function at Landmark Church. Victim stated that after an argument the suspect told her that he would knock her teeth out and burn her house down. The victim did not want to file criminal charges at this time. She could return to the station and sign charges at a later date if she chooses to. Case closed by exceptional means—victim chooses not to prosecute.

On 1/2, victim came to the station to report she was having problems with her son. Victim reported her son made threats to her over the phone and the victim took these threats seriously and made arrangements to not stay at her house for the night. Case investigation has begun.

PASSING BAD CHECKS

On 1/6, the Collections Supervisor with Sharefax came to the station to report a passing bad checks case. The suspect deposited a check in the amount of \$597.35 and the next day withdrew \$195. The check was returned as altered/fictitious. The suspect was contacted but never payed back the money owed to Sharfax. Case is under investigation.

On 1/10, the Front End Manager at Menards reported a passing bad checks case. The suspect wrote a check for merchandise in the amount of \$401.08. The check came back from the bank as non-sufficient funds. Investigation pending.
