**A RESOLUTION ADOPTING THE 2023 HAMILTON COUNTY MULTI-HAZARD
MITIGATION PLAN**

WHEREAS, the Village of Evendale, Ohio, like virtually every other community, is vulnerable to an array of natural, technological and human-caused hazards that have the potential to cause loss of life and damage to public and private property; and

WHEREAS, the Hamilton County Emergency Management & Homeland Security Agency and the Hazard Mitigation Steering Committee, comprised from representatives from the County, Municipalities, and stake holder organizations in Hamilton County, have prepared a recommended Multi-Hazard Mitigation Plan that reviews the options to protect people and property and reduce damage from these hazards; and

WHEREAS, the Village of Evendale has participated in the planning process for development to this plan, providing information specific to local and count-wide hazard priorities, encouraging public participation, identifying desired hazard mitigation strategies, and reviewing the draft plan; and

WHEREAS, the Hamilton County Emergency Management & Homeland Security Agency, with the Hazard Mitigation Steering Committee, has developed the Hamilton County Multi-Hazard Mitigation Plan (the “Plan”) as an official document of the County pursuant to the Disaster Mitigation Act of 2000 (PL-106-390) and associated regulations (44 CFR 210.6); and

WHEREAS, the Plan has been widely circulated for review by the County’s residents, Municipal officials, and regional, state and Federal partner agencies and has been revised to reflect their concerns; and

WHEREAS, the Ohio Emergency Management Agency and the Federal Emergency Management Agency have reviewed the Plan for legislative compliance and approved the Plan pending the completion of local adoption procedure; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring, that:

SECTION 1: The Hamilton County Multi-Hazard Mitigation Plan is hereby adopted as an official Plan of the Village of Evendale does hereby.

SECTION 2: The Evendale Fire Department is charged with supervising the implementation of the Plan’s recommendations as they pertain to the Village of Evendale and within the funding litigations as provided by the Village of Evendale Council or other sources.

**AN ORDINANCE APPROVING AN ADDITIONAL
APPROPRIATION IN THE GENERAL FUND TO FULFILL THE
PAYMENT REQUIREMENTS RELATED TO THE RECEIPT OF
THE OHIO EMA ARPA RETENTION GRANT AND DECLARING
AN EMERGENCY**

- WHEREAS,** Pursuant to legislation properly adopted by the Council of the Village of Evendale, certain expenditures will take place that need to be appropriately reflected as appropriations; and
- WHEREAS,** The Village of Evendale was awarded a grant from the Ohio Emergency Management Agency using ARPA Federal funds to award First Responder Retention Funds for both our Fire and Police Departments; and
- WHEREAS,** The grant funds awarded to the Fire Department total \$80,000 and the grant funds awarded to the Police Department total \$72,000 for a combined Federal grant receipt of \$152,000; and
- WHEREAS,** The funds are required to be paid to the recipients within 30 days of receipt and appropriations for these amounts are required to make that payment possible; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring, that:

SECTION I The following sum is appropriated from the unappropriated General Fund (101) to the following lines:

101.101.521110 Salaries Full Time	\$72,000.00
101.102.521110 Salaries Full Time	\$80,000.00

SECTION II This ordinance is declared to be an emergency by a concurrence of five members of Council, being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale or to provide for the daily operations of a department or office of the Village of Evendale. It is necessary that this measure be put into effect immediately because the public welfare and daily operations of the Village require that line items within the general fund budget not exceed the appropriation amounts approved by Council and it is in the public interest for the police and fire retention funds to be paid to the recipients in accordance with the terms of the retention grant. This ordinance shall be effective upon passage.

**ORDINANCE REJECTING ALL BIDS
ON THE GORMAN HERITAGE FARM
NATURE PLAYScape PROJECT
AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Evendale and the Gorman Farm desires to construct a Nature Playscape Area designated on the Gorman Farm Complex; and

WHEREAS, the Village advertised for and received a bid on the project; and

WHEREAS, The bid came in at substantially higher quotation than had been estimated and as a result, the Village desires to reject all bids and consider alternatives to the current project design before re-bidding; now,

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring that:

SECTION 1: The bid received on the Gorman Farm Nature Playscape Project, which were opened on October 4, 2023 is hereby rejected.

SECTION 2: This ordinance is declared to be an emergency by a concurrence of five members of Council, being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect because the public welfare requires the bids be rejected within the time provided in the project contract documents. This ordinance shall be effective upon passage.

WHEREAS, the Village of Evendale has received bids for THE TRAFFIC ISLAND LANDSCAPE MAINTENANCE PROJECT for calendar years 2024 through 2028 after advertising in a newspaper of general circulation in the Village of Evendale; and

WHEREAS, the Village Engineer has reviewed the bids and recommends Jeffrey Allen Corporation as the lowest and best bid;

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring that:

SECTION 1: The bid of Jeffrey Allen Corporation in the amount of \$69,565.00 is hereby accepted. The Mayor is authorized to enter into a contract with Jeffrey Allen Corporation for this project for calendar year 2024.

SECTION 2: The Mayor, with concurrence of Council, may, at his discretion, enter into a contract with Jeffrey Allen Corporation for the amounts in the bidding documents for the additional calendar years 2025, 2026, 2027 & 2028 upon successful fulfillment of the previous year's project.

SECTION 3: This ordinance is declared to be an emergency by a concurrence of five members of Council, being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect because the public welfare requires the bids to be accepted as soon as possible so future maintenance of the landscaping is provided for. This ordinance shall be effective upon passage.

**ORDINANCE AUTHORIZING MAYOR TO
ENTER INTO CONTRACT WITH RUMPKE OF OHIO, INC.,
THE LOWEST AND BEST BIDDER FOR WASTE
AND RECYCLING SERVICES FOR A THREE-YEAR
PERIOD WITH TWO ADDITIONAL OPTION YEARS
AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Evendale has received bids for Waste and Recycling in response to specifications for calendar years 2024 through 2026 and option years 2027 & 2028 after advertising in a newspaper of general circulation in the Village of Evendale; and

WHEREAS, the Village Engineer has reviewed the bids and recommends Rumpke of Ohio, Inc. as the lowest and best bid;

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring that:

SECTION 1: The bid of Rumpke of Ohio, Inc. to provide waste and recycling services in the Village of Evendale is hereby accepted. The Mayor is authorized to enter into a contract with Rumpke of Ohio, Inc. for this project for these services. Such a contract shall be substantially in the form of the Contract Agreement attached hereto and incorporated by reference herein, which agreement is hereby approved, and which shall specifically include the obligations of Rumpke of Ohio, Inc. to perform the work pursuant to the specifications on file with the Village, which shall be incorporated by reference in the Contract.

SECTION 2: The Mayor, with concurrence of Council, may, at his discretion, enter into a contract with Rumpke of Ohio, Inc. for the amounts in the bidding documents for the optional calendar years of 2027 & 2028 upon successful fulfillment of the previous years' project.

SECTION 3: This ordinance is declared to be an emergency by a concurrence of five members of Council, being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect in order to ensure the continuation of waste and recycling services in the Village beginning in the new calendar year. This ordinance shall be effective upon passage.

**ORDINANCE AUTHORIZING THE SALE OF THE EVENDALE
POLICE DEPARTMENT'S 2014 FORD EXPLORER TO MENIFEE
COUNTY, KY AND DECLARING AN EMERGENCY**

- WHEREAS,** the Village of Evendale Police Department routinely updates, replaces and maintains its fleet of equipped patrol vehicles; and
- WHEREAS,** Menifee County, KY has previously purchased an equipped Evendale patrol vehicle sold at auction, and;
- WHEREAS,** Menifee County, KY needs additional `equipped law enforcement vehicles, and;
- WHEREAS,** Menifee County, KY is desirous of purchasing another vehicle from the Village of Evendale at the identical price of the auctioned vehicle and this vehicle being of the same or lesser value; now, therefore,

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring, that:

SECTION 1: The Mayor and Police Chief are hereby authorized to take all steps necessary to transfer to Menifee County, KY, a 2014 Ford Explorer, equipped with emergency equipment, and bearing VIN# 1FM5K8AR5EGC14083 by reference herein in exchange for the payment to the Village of Evendale of \$6,300.00 in a certified check, electronic transfer, or after notice from the bank that a non-certified check has cleared and the money is in a village of Evendale account. The transfer of the patrol vehicle to Menifee County, KY is also conditioned upon Menifee County, KY signing an agreement that it is purchasing the vehicle and equipment in an as-is condition with no warranties or guaranties whatsoever.

SECTION 2: This ordinance is declared to be an emergency measure by a concurrence of five members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. The reason for said emergency is to assist in addressing the immediate need of Menifee County, KY for better law enforcement equipment which will directly benefit the citizens of Menifee County, KY, and eliminate the time and financial uncertainties of a vehicle auction for the Village of Evendale. Therefore, this ordinance shall become effective immediately.
