#### 1. Recreation

- a. Discussion on utilization of Evendale church to expand senior service- a list of current programs. Ideas were discussed for expanding services.
- b. Hiring ordinance- Seasonal to perm part-time for a custodial position to fill in when needed.
- c. Phase II update- Recreation center is schedule to be opened September 28<sup>th</sup> completion. Everything is tracking on schedule. There has been \$5000 in change orders- mainly moving electric and some flooring, if there is not enough money in recreation line item then a transfer may be needed.
- d. Update- Capital and operating budget is being worked on. A list of capital improvement items was passed out and discussed. The biggest expense is the playground surface area. The current swing set does not meet current code.
