## Gorman Heritage Farm

Mr. Patterson reported the results of their internal assessment of the use of the trust funds. As currently drafted, use of the trust funds is limited to The Farm House, The Upper Spring House and the Smoke House. GHF is evaluating options to amend the trust to permit expanded use of the funds for maintenance and repair of other buildings.

Mr. Patterson further stressed that GHF is working diligently to balance the use of the funds with the need and desire to preserve the trust

Mayor Finan reported that he has agreed on the terms of purchase for the Evendale Church, adjacent to the east entrance. Purchase price is \$240,000 paid in 3 equal payments over 3 years. The church will have limited access during that time.

Agreed in principal for a land swap with St Rita's, with Evendale taking a small sliver of land necessary for the egress to Aerohub development.

There will be ordinances in May approving a TIF for the Aerohub development, and a rezoning of the Cinti Freezer Company on Sharon Rd, to permit "Fowling"

**Fowling** is a hybrid game that combines the equipment of American football and bowling into one sport with a similar layout as horseshoes and corn hole. Most commonly played as a pastime in a tailgate or campground setting across the United States.

May agenda will also include a Public Hearing on the rezoning of a lot behind Walmart, owned by Formica, allowing for the sale of the property
