# ORDINANCE APPROVING WATER MANAGEMENT AND SEDIMENTATION CONTROL PLANS FOR NEYRA PROPERTIES, INC. AND AUTHORIZING BUILDING COMMISSIONER TO ISSUE PERMIT AND DECLARING AN EMERGENCY

WHEREAS, RVP Engineering on behalf of Neyra Properties, Inc. has submitted an application and supporting documents, including a certain set of grading plans on property it owns on Medallion Drive, behind Watkins Manufacturing and CDC Distributors, being further described as tax parcel Book 611, Page 40, Parcel #43 and in accordance with Evendale Ordinance 1466 et. seq.; and

**WHEREAS**, the Engineer of the Village has given his approval of said plans for the property to be developed by Neyra Construction, Inc. on behalf of Neyra Properties, Inc.; and,

**WHEREAS**, the plans approved by the Village Engineer appear to be in good order and in compliance with the purposes and intent of Evendale Ordinance 1466 et. seq.

## BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring that:

**SECTION 1:** The copy of the plans submitted by Neyra Properties, Inc., the property owner, in accordance with Evendale Code Section 1466 and approved by the Village Engineer are hereby attached as Appendix A and made part hereof.

**SECTION 2:** The Council of the Village of Evendale finds that notwithstanding the requirement in Section 1466.04 of the Codified Ordinances of the Village of Evendale, that such plans be held for 30 days before action by Council public policy justification exists to proceed immediately in order to obtain the benefits of the improvements, the reduction of impervious surfaces and the enhancement of greenspace, landscaping and aesthetic appeal of the site as soon as possible and Council further finds said plans as approved by the Engineer to be well taken and to comply with the intent and purposes of Ordinance 1466 et. seq., and are hereby approved by this Council.

SECTION 3: The approval of the permit is conditioned upon the owner complying with the requirements as set forth in Appendix B which includes the Application dated May 10, 2019, the Neyra Paving estimate of costs dated May 9, 2019 upon which the bond is based, and a 4 page "Supplement to Neyra Properties' 2019 Water Management and Sediment Control Application" which contains conditions which have been negotiated between the applicant and Evendale's Engineer and Law Director deemed vital to the recommended approval of the permit.

**SECTION 4:** The approval of Council of these plans shall be conditioned upon and shall not take effect until the filing of the plans with the Building Commissioner and filing of the performance bond set by Council in the amount of \$420,000.00. In addition, the issuance of the Water Management and Sedimentation Control Permit is conditioned upon Approval by the Building Department of the proposed plans.

**SECTION 5:** Copies of the plans as approved by Council shall also be filed with the Clerk, the Engineer, the Building Commissioner, the Planning Commission and the County Soil and Water Conservation District.

**SECTION 6:** Upon the filing of said approved plans with the Building Commissioner and upon the posting of the bond specified above, the Building Commissioner shall issue the appropriate permit to commence the work, etc. as provided by the approved plans.

**SECTION 7:** This ordinance shall not constitute approval for any building or structure.

**SECTION 8:** This ordinance is declared to be an emergency by a concurrence of six members of Council, being necessary to preserve the public, peace, order, safety, health or welfare of the Village of Evendale or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect because the public safety and welfare require work commence immediately to protect surrounding landowners and to assist in the economic development of Evendale. This ordinance shall be effective upon passage.

#### VILLAGE OF EVENDALE, OHIO ORDINANCE # 19-31B

AN ORDINANCE DENYING AN APPEAL FROM THE ZONING BOARD OF APPEALS REQUESTING A VARIANCE FROM THE MINIMUM REQUIRED LOT SIZE IN THE HC HEAVY COMMERCIAL DISTRICT, FOR THE SUBDIVISION OF PROPERTY LOCATED AT 10765 READING ROAD

WHEREAS, Martini on Ice, LLC ("Applicant") owns property at 10765 Reading Road,

Hamilton County Parcel Identification No. 611-30-189 ("Subject

Property"), which is 15.315-acre parcel that is the site of Sports Plus and

its parking lot; and

WHEREAS, the Subject Property is located in the HC Heavy Commercial District,

which has a minimum lot size of 2 acres per Evendale Zoning Code

("EZC") Schedule 1248.07; and

**WHEREAS**, the Board of Zoning Appeals ("BZA") reviewed a variance application

from Applicant which requested a variance from the 2-acre minimum lot size requirement, proposing a lot that is 1.103 acres and which would accommodate a Dunkin Donuts with drive-through at the Subject

Property; and

WHEREAS, A parcel similar in size was carved out of the Subject Property parcel

many years ago to accommodate the Wendy's parcel at the northeast corner of the Subject Property, at a time when the EZC had a minimum lot

size of 1 acre in the HC District, and Applicant proposes a similar

configuration at this site; and

**WHEREAS**, The Village of Evendale Zoning Board of Appeals considered that

application at its meeting on March 21, 2019, and a motion to approve the

variance failed by a 2-3 vote; and

**WHEREAS**, Council finds that the requested variance, at 135% of the EZC

requirement, is excessive; and

WHEREAS, Council finds that concerns expressed by the BZA members regarding

parking, traffic, and circulation issues related to the larger Subject

Property site are well founded; and

**WHEREAS**, Council finds that the Applicant can resolve its issue of creating an

additional commercial development at this site by either allowing a parcel that meets the 2-acre minimum or by creating a secondary principal

structure on the Subject Property, provided that the development otherwise

meets the provisions of the EZC; and

**WHEREAS**, The Council of the Village of Evendale conducted a public hearing on the

appeal at its meeting on May 14, 2019;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring:

**SECTION I** The Council of the Village of Evendale hereby finds that the requested

variance is excessive in nature at 135% of the requirements, and does not meet the variance standards of EZC Sec. 1284.05(c). Therefore, Council

hereby denies the variance.

**SECTION II** This ordinance shall take effect and be in force from the earliest date

allowed by law.

#### ORDINANCE AUTHORIZING THE MAYOR TO NEGOTIATE A DEVELOPMENT SERVICES AGREEMENT WITH NEYER PROPERTIES, INC. TO SERVE AS THE DEVELOPER FOR THE AEROHUB PROJECT AND DECLARING AN EMERGENCY

WHEREAS. The Village, in coordination with the Evendale Community Improvement

Corporation, solicited requests for qualifications for skilled development

experts to serve as the developer of the AeroHub project; and

WHEREAS, 3 applicants responded to the requests for qualifications, all three were

> asked to submit proposals, two responded and both were interviewed, and Neyer Properties, Inc. has been recommended as the best qualified to serve in the capacity of the exclusive developer of the AeroHub project; and

WHEREAS, It is now appropriate to negotiate an agreement with Neyer Properties, Inc.

which agreement will be presented to the Council of the Village of Evendale

for approval; now, therefore

#### BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF **EVENDALE, STATE OF OHIO, five members concurring, that:**

**SECTION I:** 

Neyer Properties, Inc. is hereby tentatively named as the exclusive developer for the AeroHub project provided that an appropriate contract can be negotiated between the Village of Evendale and Neyer Properties, Inc. and approved. The Mayor of the Village of Evendale is hereby authorized to attempt to negotiate such an agreement and if successful to present that

to Council for its approval by ordinance.

**SECTION II:** This ordinance is hereby declared to be an emergency measure necessary to

> preserve the health, safety, and general welfare of the Village of Evendale and/or to provide for the daily operation of an office or department of the Village. The reason for said emergency is to put in place as quickly as possible a skilled and experienced developer to move forward with the development of AeroHub on property already acquired by the Village of Evendale and to plan for further development on adjacent property which the Village may acquire, all of which is necessary to secure and benefit the economic well being of the Village. Therefore this ordinance shall become

## ORDINANCE APPROVING THE PRELIMINARY CONCEPT PLAN FOR THE "AEROHUB SOUTH" INNOVATION PUD AND DECLARING AN EMERGENCY

- **WHEREAS**, The Village of Evendale is the owner of the property as depicted on the plat provided as part of Attachment 1 and currently known as "AeroHub South"; and
- **WHEREAS**, The Council of the Village of Evendale approved amendments to Chapter 1256 of the Village of Evendale Zoning Code to include the Innovation District PUD via Ordinance #18-48 on September 11, 2018; and
- **WHEREAS,** The Council of the Village of Evendale approved a rezoning of an area known as AeroHub South (approx.13 acres) via Ordinance 18-49 on September 11, 2018; and
- WHEREAS, The Council of the Village of Evendale approved the "AeroHub Innovation District Master Plan" via Resolution #18-06 on September 11th, 2018; and
- WHEREAS, The Council of the Village of Evendale finds that the attached AeroHub South Innovation PUD Preliminary Concept Plan applies to the same area which is the subject of the rezoning for AeroHub South via Ordinance 18-49; and
- WHEREAS, The Council of the Village of Evendale finds that the attached AeroHub South Innovation PUD Preliminary Plan complies with the preliminary concept plan provisions of Evendale Zoning Code Chapter 1256 and is not contrary to the spirit and intent of the AeroHub Innovation District Master Plan; and
- WHEREAS, There is currently underway processes to vacate the public right-of-way in AeroHub South known as St. Rita Lane, and to plat a new subdivision comprised of the AeroHub South property which will include a newly established street right-of-way and other parcels, one of which is currently under contract for sale for development; and
- **WHEREAS,** The Village of Evendale intends to have the property within the newly-platted "AeroHub South" area be subject to certain covenants, conditions and restrictions, and to ultimately be controlled by a Master Association; and
- WHEREAS, The Village of Evendale Planning Commission held a public hearing and recommended approval of the AeroHub Innovation PUD Preliminary Concept Plan on January 15, 2019, and concurrently approved the Preliminary and Final Development Plans for Modal Shop, pursuant to Evendale Zoning Code Sec. 1256.13, conditioned upon Council's approval of this AeroHub South Innovation PUD Preliminary Plan approval; and
- **WHEREAS,** The Village of Evendale is the intended "Developer" as defined in the draft Declaration; and now, therefore,

## BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

- **SECTION 1:** The Preliminary Concept Plan for the "AeroHub South" Innovation PUD, attached hereto and incorporated herein as Attachment 1, is hereby approved.
- **SECTION 2:** This ordinance is declared to be an emergency measure by a concurrence of six members of Council, it being found to be necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the

daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect in order to allow the sale and development of the first parcel of AeroHub South PUD, consistent with the AeroHub Master Plan and the PUD provisions. Therefore, this ordinance shall become effective immediately.

## ORDINANCE AUTHORIZING THE FIRE CHIEF TO DONATE TWO LARGE EVACUATION FANS TO THE HAMILTON COUNTY URBAN SEARCH AND RESUCE TEAM AND DECLARING AN EMERGENCY

**WHEREAS,** The Village of Evendale Fire Department is in possession of two large fans

used to ventilate buildings when it is necessary to clear the air at emergency

sites; and

WHEREAS, Those two particular fans are no longer used by the Evendale Fire

Department as they have been replaced by newer equipment but are still

usable; and

WHEREAS, The Hamilton County Urban Search and Rescue Team has expressed a

desire to have those fans for use at sites they respond to; and

WHEREAS, The Hamilton County Urban Search and Rescue Team is a task force

comprised of first responders from political subdivisions in the Hamilton

County area including the Village of Evendale; and

WHERAS, The Hamilton County Urban Search and Rescue Team typically responds

to large scale matters and assists in the search for and recovery of victims, both here in the Hamilton County area and at disaster sites in other parts of

the tri-state area, and is an important local asset; and

**WHEREAS,** Providing the fans to the Hamilton County Urban Search and Rescue Team

will keep the fans in public use, provide an import public service, and be of continued benefit to the Village of Evendale as the Village cooperates with and benefits from the work of the Hamilton County Urban Search and

Rescue Team; now, therefore

### BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

**SECTION I:** 

The Fire Chief of the Village of Evendale is hereby authorized to transfer ownership to the Hamilton County Urban Search and Rescue Team of the following two fans:

- I. Super Vac P164SE 18" Smoke Ejector electric fan and
- II. Unifire 18" Gas Powered Fan, Serial Number DS-3P4.

**SECTION II:** 

This ordinance is hereby declared to be an emergency measure necessary to preserve the health, safety, and general welfare of the Village of Evendale and/or to provide for the daily operation of an office or department of the Village. The reason for said emergency is to put the two identified fans back into use for an important public purpose as soon as possible so that the fans may be available in the event that an emergency requires the assistance of the Hamilton County Urban Search and Rescue Team and the team requires the ability to ventilate a site during the course of their operations. **SECTION 4**: Copies of the plans as approved by Council shall also be filed with the Clerk, the Engineer, the Building Commissioner, the Planning Commission and the County Soil and Water Conservation District.

**SECTION 5**: Upon the filing of said approved plans with the Building Commissioner and upon the posting of the bond specified above, the Building Commissioner shall issue the appropriate permit to commence the work, etc. as provided by the approved plans.
