ORDINANCE #19-40**

**ORDINANCE APPROPRIATING FUNDS AND APPOINTING
ROBERT ML GREEN AS A FIRE FIGHTER/PARAMEDIC FOR
THE VILLAGE OF EVENDALE AND DECLARING AN
EMERGENCY.**

WHEREAS, The Mayor of the Village of Evendale, after complying with Ordinance 258.025 to 258.029, of the Codified Ordinances of the Village of Evendale, has recommended the appointment of Robert ML Green as a fire fighter/paramedic for the Village of Evendale; and

WHEREAS, The Council of the Village of Evendale concurs in the appointment described above; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

SECTION 1: Robert ML Green, is hereby employed as Fire Fighter/Paramedic. The seniority date for Robert ML Green shall be July 10, 2019. The starting salary for Robert ML Green as a fire fighter/paramedic shall be, Step 1, \$21.78 per hour, \$60,025.68 based on 2,756 hours per year. Robert ML Green, Unit # 1, shall report for work beginning July 10, 2019, at 07:00 hours. The appointment is contingent upon the individual passing a pre-employment medical and psychological examination in accordance with Section 258.032 of the Codified Ordinances of the Village of Evendale. The first year of employment shall be a probationary period. After completion of the first year probationary period, if the performance rating is satisfactory, the fire fighter shall be made a regular fire fighter/paramedic. Thereafter, continued employment is conditioned upon employee's maintenance of required certifications for fire fighters and paramedics, compliance with minimum required physical standards contained in the Standard Operating Guidelines (SOG) Manual of the Evendale Fire Department and conformance to the Evendale Municipal Code.

SECTION 2: The following additional appropriation is hereby approved to fund additional expenses related to hiring new fire fighters/paramedics:
Fire Department:

210-219	Personnel Expenses	\$4,500.00
230-239	Contractual Services	\$1,500.00

SECTION 3: This ordinance is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect because the public welfare requires that the Fire Department be kept at proper strength. It shall therefore take effect and be in force immediately from and upon passage.

**VILLAGE OF EVENDALE, OHIO
ORDINANCE #19-42**

**AN ORDINANCE AUTHORIZING THE PAYMENT OF AMOUNTS DUE UPON
CERTAIN CONTRACTS REQUIRING CERTIFICATION OF AVAILABILITY OF
FUNDS AND DECLARING AN EMERGENCY.**

WHEREAS, Ohio Revised Code 5705.41(D)(1) provides that where contracts have not been previously certified for sufficient funds being available, Village Council may authorize the drawing of warrants to pay such contracts upon receipt of a certificate from the fiscal officer stating that there was at the time of the making of such contract or order and at the time of the execution of such certificate, a sufficient sum appropriated for the purpose of such contract and in the treasury or in the process of collection to the credit of an appropriate fund free from any previous encumbrances, and

WHEREAS, Certain contracts enumerated below are now due and payable for which such a certificate has been provided by the Chief Fiscal and Accounting Officer;

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF
EVENDALE, STATE OF OHIO, six members concurring, that:**

SECTION I The Council of the Village of Evendale hereby approves and authorizes the payment of the following contracts for which the Chief Fiscal and Accounting Officer has provided a certificate that a sufficient sum has been appropriated for the purpose of each contract and is in the treasury or in the process of collection to the credit of the appropriate fund free from any previous encumbrances:

- 1) K&M Auto & Truck Repair - \$3,231.60 – Water and 2014 Dump truck repairs

SECTION II This Ordinance is declared to be an emergency by a concurrence of six members of Council, being necessary to preserve the public peace, order, safety, health and welfare of the Village or to provide for the daily operation of a department or office of the Village. The reason for said emergency is the need to approve this ordinance in the time required by the Ohio Revised Code and to ensure prompt payment to vendors. Therefore, this Ordinance shall be effective upon adoption.

**AN ORDINANCE APPROVING THE HIRING AND APPOINTING OF
ANDREW E. RODNEY AS BUILDING, PLANNING AND ZONING
MANAGER OF THE VILLAGE OF EVENDALE AND DECLARING
AN EMERGENCY**

- WHEREAS,** the Village of Evendale Administration Department has an immediate need to fill the full-time, exempt, at-will position of Building, Planning and Zoning Manager position due to the planned retirement of the incumbent in August 2019; and
- WHEREAS,** The Village of Evendale advertised the position in accordance with personnel code requirements and interviewed 4 candidates who all met or otherwise exceeded the job minimum qualifications as established in the job description.
- WHEREAS,** the Mayor of the Village of Evendale and the Evendale Hiring Committee recommend the hire and appointment of Rodney E. Andrew; and
- WHEREAS,** the position, currently titled “Building Clerk” is a non-exempt position within a fixed 4-step pay scale; however, in recognition of Mr. Rodney’s past professional employment attributes, coupled with Evendale’s desire to attract and retain high-quality candidates for the position, Council is agreeable to offering the position as Exempt with a fixed starting salary; now, therefore

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

- SECTION 1:** Andrew E. Rodney is hereby employed as the full-time (40 hour/wk.) Building, Planning and Zoning Manager of the Village of Evendale, in accordance with the attached job description, to begin employment on August 5, 2019 at a starting salary of \$65,0000 and being afforded all other compensatory options as provided for full-time employees in the Evendale Personnel Code.
- SECTION 2:** Andrew Rodney’s hiring and continued employment is conditioned upon the following; successfully passing a criminal background check; successfully passing a medical exam and drug test; earning the International Code Council (ICC) Permit Technician certification within one year of his first date of employment; good behavior; satisfactory performance and compliance with the laws and ordinances of the Village of Evendale; however, the position is considered at-will.
- SECTION 3:** This ordinance is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect because the public welfare requires the Building, Planning and Zoning Department, which is operated by the Building, Planning and Zoning Manager, be kept at proper strength so assure critical services are timely delivered. Therefore, this ordinance shall take effect and be in force immediately upon adoption.

**AN ORDINANCE APPROVING THE REHIRING AND
APPOINTING OF PETER L. FAILLACE AS A POLICE OFFICER
OF THE VILLAGE OF EVENDALE AND DECLARING AN
EMERGENCY**

- WHEREAS,** the Village of Evendale Police Department has an immediate need for an additional police officer; and
- WHEREAS,** Peter L. Faillace served to the Third Step as an Evendale Police Officer before leaving on good terms to become a member of the Cincinnati Police Department; and
- WHEREAS,** the Mayor of the Village of Evendale, has recommended the rehire and appointment of Peter L. Faillace as a Village Police Officer; and
- WHEREAS,** Council, recognizing the immediate need and the opportunity to return to Evendale Police Department a well-regarded experienced officer to fill that need, concurs in the recommendation of this appointment; now, therefore

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

SECTION 1: Peter L. Faillace is hereby employed as a Police Officer of the Village of Evendale to begin employment on July 16, 2019 after completing his service to the City of Cincinnati and being sworn in by the Mayor as a Police Officer at the Step Four salary, then in effect for the Village of Evendale Police Officers. His prior service as an Evendale officer shall count as seniority when considering promotions, but, by agreement, may not be used for shift bid purposes.

SECTION 2: Peter L. Faillace shall serve a six months probationary period following his return to service as an Evendale Police Patrolman. After completion of that six months of probationary period, if performance is satisfactory, said officer shall be made a regular Village of Evendale Police Officer. Thereafter, employment is conditioned upon the employee's maintenance of the required certification for a police officer, compliance with the minimum required physical standards, conformance to the Evendale Municipal Code and good behavior.

SECTION 3: This ordinance is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect because the public welfare requires the Police Department be kept at proper strength and the addition of this returning officer is critical to accomplishing that. Therefore, this ordinance shall take effect and be in force immediately upon adoption.
