AN ORDINANCE AUTHORIZING THE PAYMENT OF AMOUNTS DUE UPON CERTAIN CONTRACTS REQUIRING CERTIFICATION OF AVAILABILTY OF FUNDS AND DECLARING AN EMERGENCY.

WHEREAS,

Ohio Revised Code 5705.41(D)(1) provides that where contracts have not been previously certified for sufficient funds being available, Village Council may authorize the drawing of warrants to pay such contracts upon receipt of a certificate from the fiscal officer stating that there was at the time of the making of such contract or order and at the time of the execution of such certificate, a sufficient sum appropriated for the purpose of such contract and in the treasury or in the process of collection to the credit of an appropriate fund free from any previous encumbrances, and

WHEREAS,

Certain contracts enumerated below are now due and payable for which such a certificate has been provided by the Chief Fiscal and Accounting Officer;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring, that:

WHEREAS,	Nancy Hagner will soon retire after many years of loyal service to the Village, retiring as the Recreation Program Supervisor; and
WHEREAS,	Sarah Hilton has held various positions in the Recreation Department over the last 12 years, serving most recently on a part-time basis as Recreation Programmer; and
WHEREAS,	Sarah Hilton has considerable experience working closely with Nancy Hagner and has demonstrated her ability to take on the duties of Recreation Program Supervisor on a full-time basis; and
WHEREAS,	the Recreation Director of the Village of Evendale, having had the opportunity to closely evaluate the work and abilities of Ms. Hilton has recommended her to fill the position of Recreation Program Supervisor being vacated by Ms. Hagner; and
WHEREAS,	the Mayor of the Village of Evendale, having substantially complied with the hiring requirements of Chapter 258 of the Codified Ordinances of the Village of Evendale, has recommended the appointment of Ms. Hilton as Recreation Program Supervisor;

ORDINANCE ADOPTING § 258.127 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF EVENDALE AUTHORIZING THE MAYOR TO PROMULGATE A VOLUNTARY LEAVE DONATION POLICY AND DECLARING AN EMERGENCY

WHEREAS, The State of Ohio through Ohio Revised Code Section 124.391 authorizes

the Director of the Department of Administrative Services, to establish a program allowing state employees the ability to voluntarily donate accrued but unused paid leave to another employee who is in need of leave as a result of circumstances such a serious illness or the serious illness of a

member of the employees immediately family; and

WHEREAS, Many local governments have adopted similar programs; and

WHEREAS, An Evendale firefighter/paramedic, who only recently began his service in

that position, was recently badly injured prior to having the opportunity to

accrue any substantial amount of leave time; and

WHEREAS, Some employees have indicated a desire to donate leave time to that

employee, but Evendale does not currently have a program providing for

such donations; now therefore,

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO five members concurring that:

§ 258.127 of the Codified Ordinances of the Village of Evendale is hereby adopted to read as follows:

§ 258.127 Donating Accrued Leave

The Mayor of the Village of Evendale is authorized to promulgate a Leave Donation Policy allowing employees to voluntarily donate a limited amount of accrued leave to another Village employee who, because of extraordinary circumstances, has insufficient leave time available to allow for the recuperation from an illness or injury of him or herself or an immediate family member. Such Policy may be made retroactive to July 15, 2019. Such Policy may be changed from time to time by the Mayor. When adopted or changed said Policy shall be distributed to all Village employees.

SECTION 2:

This ordinance is hereby declared to be an emergency measure necessary to preserve the health, safety and general welfare of the Village of Evendale or to provide for the daily operation of a department or office of the Village of Evendale. This Ordinance is declared to be an emergency in order to allow it to be put in place as rapidly as possible so that those employees that want to donate a portion of their accumulated leave time to another employee who needs it can do so as soon as possible. Therefore, this ordinance shall become effective immediately.

- **WHEREAS**, the Village of Evendale participates in a joint purchasing plan operated by the State of Ohio Department of Transportation; and
- **WHEREAS**, the Village of Evendale, as do many other local governments including Sharonville, participates in a national joint purchasing plan operated by the State of Minnesota called Sourcewell, formally the National Joint Powers Alliance (NJPA); and
- **WHEREAS**, the Charter of the Village of Evendale requires that each purchase exceeding twenty-five thousand dollars (\$25,000.00) be approved by the Council of the Village of Evendale; and
- WHEREAS, the Council of the Village of Evendale has determined that it is necessary and appropriate for the Village to purchase a dump truck to cover expanded needs due to assignment of Neuman Way maintenance by ODOT; now, therefore,

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring, that:

SECTION 1: The Council of the Village of Evendale authorizes the purchase of a single axle Freightliner Cab and Chassis system and associated accessories meeting the specifications and requirements as set in the State of Ohio Department of Transportation Purchasing Program from Fyda Freightliner in the amount of \$79,983.

SECTION 2: The Council of the Village of Evendale authorizes the purchase and installation of a 10' Mark E dump body, snow plow, snow removal equipment, pre-wetting system, safety lights and associated accessories meeting the specifications and requirements as set in the Sourcewell Purchasing Program from Henderson Products, Inc in the amount of \$60,595.

SECTION 3: The following sum is appropriated in the State Highway Improvement Fund:

WHEREAS, Funds are required to supplement the personnel expense line items in order to

meet payroll and benefit costs associated with the new position and to fund

retirement costs; and

WHEREAS, Funding is available in the contingency line item to supplement the funds

necessary; now

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring, that:

SECTION 1: The following sum is transferred from the General Fund Contingency Fund account:

101.799.579900 \$ 35,000.00

To the 499 Building Department:

210-219 Personnel Expenses \$ 35,000.00

SECTION 2: These appropriated funds are authorized to be expended for personnel expenses

in the Building Department.

SECTION 3: This ordinance is declared to be an emergency measure by a concurrence of five

members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect because the public welfare and daily operations of the Village require that line items within Fund budgets not exceed the appropriation amounts approved by Council and it is in the public interest to properly compensate the new Building, Planning and Zoning Manager and to provide for retirement expenditures. This ordinance shall be effective upon passage.
