VILLAGE OF EVENDALE, OHIO RESOLUTION #19-05

AN ORDINANCE APPOINTING JAESON HUDNALL AS A SPECIALIST IN THE FIRE DEPARTMENTAND DECLARING AN EMERGENCY.

- **WHEREAS**, the Council of the Village of Evendale desires to maintain an efficient work force and insure that the specialist positions previously created remain fully occupied; and
- **WHEREAS,** Roger Neff has retired from the Fire Department leaving open one of the designated specialists positions who serve as department inspectors; and
- **WHEREAS,** Jaeson Hudnall has been filing the position since August 4, 2019 and the Fire Chief has recommended that Council approve Jaeson Hudnall to fill that specialist position retroactive to Aug 4, 2019.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

- **SECTION 1:** Jaeson Hudnall shall fill a department inspector position as a designated specialist in the fire department effective retroactively to August 4, 2019, until December 31, 2019. For his services as a specialist through the end of the year Jaeson Hudnall shall be paid \$305 additional compensation over and above his regular salary in one lump sum with the first full pay period in December of 2019. Hudnall, as with all specialists, may be removed prior to December 31, 2019 by disciplinary action taken under the personnel ordinances or Fire Department Rules and Regulations of the Village of Evendale.
- SECTION 2: This ordinance hereby declared to be an emergency measure necessary to preserve the health, safety and general welfare of the Village of Evendale and its citizens or to provide for the daily operation of a department or office of the Village of Evendale. The reason for said emergency is to ensure the safe use of streets in the Village of Evendale. Therefore, this Ordinance shall become effective immediately.

AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE A DEVELOPMENT SERVICES AGREEMENT WITH NEYER PROPERTIES, INC. FOR THE AEROHUB PROJECT AND DECLARING AN EMERGENCY

WHEREAS, The AeroHub project is a critical component of the Village of Evendale's

future economic success; and

WHEREAS, In support of that project, Evendale has acquired significant property and

plans on additional acquisitions; and

WHEREAS, In order to maximize the opportunities to fulfill the goals of the AeroHub

project, it was determined that additional development expertise is

necessary; and

WHEREAS, The Village of Evendale, with the assistance of the Community

Improvement Corporation, sought requests for qualifications and requests for proposals and conducted interviews ultimately determining that Neyer Properties, Inc. was best suited to provide the necessary expertise and

support to the Village. Now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring, that:

SECTION I The Mayor is hereby authorized to enter into a development services

agreement substantially in the form of the agreement attached hereto and

incorporated by reference herein.

SECTION II This Ordinance is hereby declared to be an emergency by a concurrence of

five members of Council, being necessary to preserve the health, safety and general welfare of the Village of Evendale and to provide for the daily operation of a department or office of the Village. The reason for said emergency is the necessity to move forward as rapidly as possible to bring to fruition the AeroHub project creating new employment opportunities and economic benefits in the Village of Evendale. Therefore, this

ordinance shall become effective immediately.

Evendale certain expenditures will take place that need to be appropriately

reflected as appropriations; and

WHEREAS, Funds are requested for expenditures related to updating the Mayors Court

software, required licensure and hardware support; and

WHEREAS, Funds are available in the Court Computer fund; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

SECTION 1 The following sum is authorized to be expended from the 204 Court

Computer Fund:

204.703.524200 Operating Expense \$41,400.00

SECTION 2 This ordinance is declared to be an emergency by a concurrence of six

members of Council, being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale or to provide for the daily operations of a department or office of the Village of Evendale. It is necessary that this measure be put into effect immediately because the public welfare and daily operations of the Village require that line items within departmental budgets not exceed the appropriation amounts approved by Council and it is in the public interest for the Village to operate the Mayors Court in the most effective and efficient manner as soon as possible.
