ORDINANCE MAKING APPROPRIATIONS FOR THE CARES ACT FUND FOR THE FISCAL YEAR ENDING DECEMBER 31, 2020 AND DECLARING AN EMERGENCY

WHEREAS, it is necessary to make an appropriation for current expenses and for the fiscal year ending December 31, 2020

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring that:

SECTION 1: The purpose of the ordinance is to provide for current expenses and other expenditures of the Village of Evendale during the fiscal year ending December 31, 2020 related to the newly formed CARES Act Fund,

<u>SECTION 5:</u> The funds appropriated for salaries pursuant to this ordinance shall be paid in accordance with the **Salary Schedule and the 2020 Part Time Pay Schedule** previously approved for the 2020 Fiscal Year.

SECTION 6: This ordinance is declared to be an emergency measure by a concurrence of six members of Council, being necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency being the legal need to promptly forward the 2020 Appropriation Ordinance to Hamilton County authorities and shall therefore take effect and be in force immediately from and upon passage.

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH THE LOWEST AND BEST BIDDER FOR THE OPERATION OF THE EVENDALE RECREATION CENTER'S FITNESS CENTER AND DECLARING AN EMERGENCY

WHEREAS, the Village of Evendale has publicly advertised for bids in a newspaper of

general circulation in the Village of Evendale for the operation of the

Recreation Center's Fitness Center; and

WHEREAS, two bids were received and considered, however, only the bid of FITMEES,

LLC met the requirements of the bid since the other bidder failed to include

the required bid and performance bonds; and

WHEREAS, as a result, FITMEES, LLC is hereby found to be the lowest and best bidder to

operate the Fitness Center for 2021 and 2022 with options for the following

two years, 2023 and 2024; now therefore

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, and six members concurring that:

SECTION 1: The bid of FITMEES, LLC in the amount of \$93,100.00 for 2021 and

\$95,700.00 for 2022 is hereby accepted. The Mayor is authorized to enter into a contract with FITMEES, LLC, said contract to conform with the requests for proposal issued by the Recreation Department and the bid response submitted

by FITMEES, LLC.

SECTION 2: This ordinance is declared to be an emergency measure by concurrence of six

members of Council, it being necessary to preserve the public peace, order, health, safety and welfare of the Village of Evendale and to provide for the daily operation of a department or office of the Village of Evendale, in this case, the Recreation Department. It is necessary that this measure be put into immediate effect because the Public Health and Welfare requires that the village have a fitness center management contract in place as soon as possible in order to prepare the fitness center for the 2021 operation and to insure the fitness center program is open, staffed and operating in a timely fashion without interruption when the current contract expires at the end of the year.

Therefore, this Ordinance shall be effective upon passage.

AN ORDINANCE RATIFYING A REAL ESTATE PURCHASE AGREEMENT BETWEEN THE VILLAGE OF EVENDALE AND DYNAMIC SIGHT PROPERTIES LTD. AND FIRST AND SECOND EXTENSIONS TO SAID CONTRACT AND AUTHORIZING THE THIRD EXTENSION AND AMENDMENT TO SAID CONTRACT AND DECLARING AN EMERGENCY

WHEREAS, Kinetic Vision is an important corporate citizen of the Village of Evendale; and

WHEREAS, Kinetic Vision intends to relocate and in order to remain in the Village of Evendale, and on its behalf Dynamic Sight Properties, Ltd. executed a contract to purchase real estate in AeroHub North on April 14, 2020; and

whereas, due to issues related to the COVID pandemic and financing, extensions of said contract have been necessary, a first extension being entered into on July 14, 2020 and a second extension of time on September 10, 2020; and now Dynamic Sight Properties desires to enter into a third extension of time and will pay for that extension; and

WHEREAS, while Dynamic Sight Properties, Ltd. needs a further extension of time in order to complete its acquisition of the property, Dynamic has already obtained, by Ordinance No. 20-31 adopted on May 12, 2020, a water management and sediment control plan for the property to be purchased, and on May 19, 2020, obtained Planning Commission approval for the final development plan and on June 16, 2020, obtained Planning Commission approval for the final landscape plan; and

WHEREAS, the Village of Evendale desires to continue to cooperate with Dynamic Sight Properties, Ltd. and Kinetic Vision, in order to ensure that they remain in the Village of Evendale, and become the first corporate residents of AeroHub North; now therefore

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, and six members concurring that:

Council of the Village of Evendale hereby approves and ratifies the contract to purchase real estate between the Village of Evendale and Dynamic Sight Properties, Ltd. that had been entered into on April 14, 2020 and the first and second extensions of time and by this Ordinance authorizes the Mayor to enter into an agreement providing a third extension of time that will require the closing on the property to occur no later than May 31, 2021, conditioned upon Dynamic Sight Properties, Ltd. or Kinetic Vision paying to the Village of Evendale, a \$20,000.00 extension fee within 20 business days of the execution of the third extension. Ten Thousand Dollars (\$10,000.00) of the extension fee will be credited towards the purchase price of the property if closing on said property occurs on or before May 31, 2021.

SECTION 2:

This ordinance is declared to be an emergency measure necessary to preserve the health, safety and general welfare of the Village of Evendale or to provide for the daily operation of a department or office of the Village of Evendale. The reason for said emergency is to meet Evendale's desire that Dynamic Sight Properties, Ltd. and Kinetic Vision of Evendale's remains important, corporate citizens of the Village, preserving their jobs in the Village and providing for Kinetic Vision to be the initial high-tech corporate entity to be located in Aero Hub North. Therefore, this Ordinance shall be effective immediately.

RESOLUTION REGARDING THE CORONAVIRUS AID, RELIEF AND ECONOMIC SECURITY ACT AND COMPLIANCE WITH OHIO SB 614

WHEREAS, the Coronavirus Aid, Relief, and Economic Security Act, 116 Public

Law 136, (the CARES Act) was signed into law by the President of the

United States on March 27, 2020; and

WHEREAS, the Ohio General Assembly established a process for distributing

funds provided by the "Coronavirus Aid, Relief, and Economic Security Act" in House Bill 481 of the 133rd General Assembly (H.B. 481) and subsequently amended by House Bill 614 October 2020; and

WHEREAS, addressing Coronavirus, and taking substantial steps to reduce and

prevent its spread, required a substantial reassignment of Village

employees to tasks specific to that effort; and

WHEREAS, it also required the expenditure of funds to acquire PPE, sanitizing and

cleaning materials as well as expanding cleaning services both internally and contracted specifically to address pandemic related

issues; and

WHEREAS, it also required capital expenditures be made to improve the ability to

treat Covid19 patients as well as provide for the safety of Village

personnel; and

WHEREAS, the Village of Evendale has documented these personnel and other

expenditures and determined they are entitled to reimbursement under the Hamilton County Coronavirus Relief Distribution Fund; now

therefore,

BE IT RESOLVED by the Council of the Village of Evendale, State of Ohio,

six members concurring, that:

SECTION 1: The Mayor and Village Counsel of the Village of Evendale affirms that all funds received from the County Coronavirus Relief Distribution Fund pursuant to H.B. 481/614 be expended only to cover costs of the subdivision consistent with the requirements of the CARES Act and thereby documents that the following Recreation Department personnel were and are performing substantially different functions due to the response to COVID 19 as follows:
