## ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE AND CONVEY A UTILITY EASEMENT TO DUKE ENERGY, OHIO AND DECLARING AN EMERGENCY

- WHEREAS, As part of the proposed work of the Duke Energy Central Corridor Pipeline Project, Duke Energy, Ohio's contractor will need to install the gas main under Reading Road and the Mill Creek; and
- **WHEREAS,** this work once started will have to be performed continuously as to not collapse the tunnel and allow for the pipeline to be pulled through; and
- **WHEREAS,** in order to perform this work, sufficient space is needed to prepare and join the sections of pipe to be installed underground; and
- WHEREAS, Duke has proposed a temporary and permanent utility easement on the property the Village owns in the area of the northeast corner of Glendale Milford and Reading Road; and
- WHEREAS, After several rounds of negotiation between the Village Mayor Finan and Duke Energy, Ohio project team and Agreement has been reached which the Mayor recommends be approved and now, therefore,

# **BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:**

- **SECTION 1:** The Mayor is authorized to execute and convey an utility easement and associated temporary easement for construction purposes from the Village of Evendale to Duke Energy, Ohio as shown in the exhibit A attached herein.
- **SECTION2:** In exchange for this easement, Duke Energy, Ohio shall pay the Village of Evendale the amount of \$182,952.00 in accordance with the provisions of exhibit B attached herein.
- **SECTION 2:** This ordinance is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into effect so that the project may proceed as conditions permit. Therefore, this ordinance shall become effective immediately.

### ORDINANCE AUTHORIZING MAYOR TO SET 2021 PART-TIME EMPLOYEE PAY RATES AND DECLARING AN EMERGENCY

**WHEREAS,** the Council of the Village of Evendale has enacted Chapter 258 of the Codified Ordinances of the Village of Evendale requiring authorization by Council for the Mayor to hire time employees; and,

**WHEREAS**, the Mayor has submitted a list of part-time employees who may be employed or reemployed for the next year ending December 31, 2021.

**WHEREAS**, the Mayor has fully complied with Chapter 258 of the Codified Ordinances of Evendale and recommended that Council authorize the hiring of the individuals specified below for part-time positions for which employment is authorized by this ordinance.

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring that:

**SECTION 1:** The following persons included in the attached 2021 Part Time Pay Schedule may be employed during the year ending December 31, 2021, by the Mayor of the Village of Evendale as part-time employees at the hourly rate established therein.

**SECTION 2**: This ordinance is declared to be an emergency by a concurrence of five members of Council, being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect because the public welfare requires that the Mayor have authority to employ or reemploy the persons set out above as necessary when the New Year begins. This ordinance shall be effective upon passage.

## AN ORDINANCE UPDATING SECTIONS OF CHAPTER 258, EMPLOYEES GENERALLY, OF THE EVENDALE MUNICIPAL CODE AND DECLARING AN EMERGENCY

- **WHEREAS**, recent issues have established that certain updates need to be made to Chapter 258, Employees Generally, of the Evendale Municipal Code; and
- **WHEREAS,** the phrase "or Police Department employee" in Section 258.125, Bereavement Policy, is unnecessary and causes confusion; and
- **WHEREAS,** Section 258.164, Grounds for Disciplinary Action, should be amended in subsection (ff) to make it clear that being intoxicated on the job is grounds for discipline;
- WHEREAS, similarly subsection (gg) of Section 258.164 should be amended to make it clear that being under the influence of an illegal drug or narcotic while on the job is grounds for discipline; now therefore

**BE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO**, and six members concurring that:

**SECTION 1**: Section 258.125, Bereavement Leave, is hereby amended to read as follows:

"In the event of death in the family, a 37.5 hour or 40-hour employee will be granted a paid leave of absence up to three working days, and a firefighter will be granted a paid leave of absence of one 24-hour work day. In the event the funeral is held outside of a 200-mile radius of the Village, bereavement leave shall be extended up to five (5) days (two 24-hour days for a firefighter). Any extension beyond those periods shall be deducted from an employee's sick leave. The employee shall give prior notification to the department head or designee that the bereavement leave is requested. Each bereavement leave shall be considered a separate event."

**SECTION 2**: Section 258.164, (ff) is amended to read as follows:

"(ff) being possession of, drinking alcoholic beverages on the job or being intoxicated on the job."

**SECTION 3**: Subsection 258.164, (gg) shall be amended to read as follows:

"(gg) the use of or sale of any illegal drug or narcotic, or being under the influence of any illegal drug or narcotic while on the job or the misuse of a legal drug or narcotic while on the job."

**SECTION 4:** This ordinance is hereby declared to be an emergency measure, being necessary to preserve the health, safety and general welfare of the Village of Evendale or to provide for the daily operation of the Department or Office of Evendale. The reason for said emergency is to ensure that the Code of Ordinances, as it impacts Village employees generally, is clear about the benefits, which are fairly and consistently stated and provided, and the grounds for discipline are as intended and assist in protecting Village employees. Therefore, this Ordinance shall be effective immediately.

## NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

- **SECTION I** The Council of the Village of Evendale hereby approves and authorizes the payment of the following contracts for which the Chief Fiscal and Accounting Officer has provided a certificate that a sufficient sum has been appropriated for the purpose of each contract and is in the treasury or in the process of collection to the credit of the appropriate fund free from any previous encumbrances:
  - 1) Hamilton County Treasurer Storm water fee \$40,119.00
- **SECTION II** This Ordinance is declared to be an emergency by a concurrence of six members of Council, being necessary to preserve the public peace, order, safety, health and welfare of the Village or to provide for the daily operation of a department or office of the Village. The reason for said emergency is the need to approve this ordinance in the time required by the Ohio Revised Code and to ensure prompt payment to vendors.
