reasonable and appropriate to provide for an employee recovering from an injury or medical condition to return to work in a transitional or light duty status; and

WHEREAS, the employee may be unable to perform the full duties associated with his regular

employment, still he or she may be able to provide services to the Village and contribute to the betterment of the community as an employee performing light duties as he or she prepares to resume normal duties; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

SECTION 1: The **Transitional Duty Policy attached** hereto and incorporated by reference

herein is hereby adopted and department heads and other supervisory personnel

are directed to implement it and utilize it when appropriate.

SECTION 2: This ordinance is declared to be an emergency measure by a concurrence of six

members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. The reason for said emergency is to have in place as soon as possible a policy which allows injured employs or those recovering from a medical situation to return to work in a capacity that allows them to perform valuable service for the Village, even if not there full and regular position. Therefore, this ordinance shall become

effective immediately.

VILLAGE OF EVENDALE, OHIO ORDINANCE #17-03

ORDINANCE ADOPTING SECTION 238.02 ALLOWING POLITICAL SIGNS TO BE POSTED IN SPECIFIC AREAS ON THE VILLAGE OF EVENDALE MUNICIPAL CAMPUS ON ELECTION DAYS

WHEREAS, the Village of Evendale recognizes that political signs are a valued part of the

American democratic process; and

WHEREAS, currently the single polling place for all registered voters in the Village of

Evendale is in the center of the Evendale municipal campus in the Recreation

Center building; and

WHEREAS, there are ample locations leading to the entrance to the polling place where

political signs could be placed on the Village campus outside the 100-foot campaign-free zone established by Ohio Revised Code Section 3501.35 that would provide for ample opportunity for candidate or ballot issue proponent or

opponent to post signs; now, therefore,

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring, that:

SECTION 1: Section 238.02 of the Codified Ordinance of the Village of Evendale is hereby adopted to read as follows:

Section 238.02 POLITICAL SIGNS ON THE VILLAGE CAMPUS ON ELECTION DAY

The Director of Administrative Services of the Village of Evendale is hereby authorized and directed to designate an area or areas on the Village of Evendale campus where political signs of candidates or ballot issue proponents or opponents may post political signs on any election day. Such signs may be no larger than a total of 8 square feet in size including both sides of a two sided sign, and be installed no earlier than 10:00 P.M. on the day before the election and must be removed by 10:00 P.M.. Signs installed on Village of Evendale property prior to such time or remaining after such time or posted in undesignated areas may be confiscated and disposed of by the Village of Evendale. Signs may only be installed in a manner that does not damage Village property. The cost of repairing any damage to Village property caused by such signs shall be assessed against the campaign or campaigns of the candidate or candidates or issue supporters or opponents on whose behalf such signs were installed. The location where signs may be installed must be no closer than 100 feet from the door of the building or buildings in which voting is taking place. All candidates and ballot issue proponents and opponents shall have an equal right to post said signs.

SECTION 2: This ordinance shall take effect and be in force from the earliest date allowed by law.

A RESOLUTION APPOINTING SPECIALISTS IN THE SERVICE DEPARTMENT FOR 2017 AND DECLARING AN EMERGENCY

WHEREAS, the Council of the Village of Evendale desires to maintain an efficient

workforce; and,

WHEREAS, by past ordinances, Council of the Village of Evendale has established

specialist positions within the Fire, Police and Service Departments and

provided for certain additional compensation for each position; and

WHEREAS, the Council of the Village of Evendale believes that such practice has

worked well in the past and desires to continue it; and

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

SECTION 1: Effective from January 1, 2017, until December 31, 2017, the following are appointed as designated specialists in the Fire Department:

- A. Pesticide Specialist, Steve Knebel
- B. Safety Specialist, Shannon Lynch

<u>SECTION 2</u>: Each specialist appointed by this Resolution shall receive additional compensation in addition to the salary otherwise paid to them in the amount of \$750 per year, which shall be paid in one lump sum with the first full paid period in December of 2017.

SECTION 3: Persons appointed to specialists positions designated in Sections 1 of this Resolution shall maintain their status in those positions until December 31, 2017, unless or until otherwise removed prior to that date by disciplinary action taken under personnel ordinances, or Village or Department rules and regulations.

SECTION 4: This Resolution is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operations of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect because the current specialist appointments expire December 31, 2017, and the new specialists need to be in place at the time of that expiration. Therefore, this resolution shall be effective upon passage.

A RESOLUTION TO TAKE THOSE STEPS NECESSARY TO COMPLY WITH THE OHIO UNIFORM DEPOSITORY ACT AND DESIGNATE AN ACTIVE, INTERIM AND INACTIVE ACCOUNTS

WHEREAS, the Council of the Village of Evendale has determined it appropriate to

take steps to comply with the Ohio Uniform Depository Act; and,

WHEREAS, every five years it is necessary to update depository agreements and the

current five year term for the Village's depositories are about to expire;

now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

SECTION 1: That on an estimate duly made, monies of the Village of Evendale, aggregating a maximum amount in each of the following categories shall be awarded as deposits pursuant to the Ohio Uniform Depository Act:

Active Deposits Four Million Dollars (\$4,000,000.00)
Interim Deposits Three Million Dollars (\$3,000,000.00)
Inactive Deposits Fifteen Million Dollars (\$15,000,000.00)

(The designation of maximum amount does not guarantee a minimum.)

SECTION 2: Be it further resolved that the active, interim and inactive monies of the Village of Evendale shall be deposited in a bank or banks as provided pursuant to the Ohio Uniform Depositories Act after a period of advertising and notice as required by law and at the Village of Evendale Council meeting on May 9, 2017 at 7:00 p.m. a designation will be made for the appropriate depository for each category of funds.

<u>SECTION 3</u>: Be it further resolved that the bids shall be received until a date set by the Chief Fiscal and Accounting Officer and published in an appropriate legal notice. That notice shall be given by publication once a week for two consecutive weeks, and by mail to banks located in or near the Village.

SECTION 4: Be it further resolved that following such designation, the Chief Fiscal and Accounting Officer is hereby authorized to deposit said funds in the bank or banks offering the highest rates of interest per annum on each category of deposits (active, interim and inactive) for a period of a minimum of two years from the date the initial deposit is made.

WHEREAS, the Village of Evendale has been approached by the football coach of Aiken

High School about the possibility of obtaining the bleachers at the athletic field on the Landmark property recently acquired by the Village of Evendale; and

WHEREAS, the bleachers are of no use to the Village of Evendale and the plan had been to

demolish them and have them removed; and

WHEREAS, it would save the Village the expense of having to tear them down if the

Cincinnati Board of Education, through Aiken High School, made arrangements

to remove them for their own future use; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

SECTION 1:

The Mayor or his designee is authorized to execute an agreement satisfactory to the Law Director of the Village of Evendale to convey the bleachers on the former Landmark property to the Cincinnati Board of Education providing that the agreement specify that the bleachers are being accepted as a donation in an asis condition with no warranties or guarantees whatsoever with regard to their condition and that the Village of Evendale and its officials and employees are held harmless for any injuries or damages that may result either from the removal of the bleachers or the use of the bleachers in the future. Said agreement shall also require the Cincinnati Board of Education to provide an acceptable plan for the safe removal of the bleachers in such a way as the remainder of the property owned by the Village of Evendale will not be damaged.

SECTION 2:

This ordinance is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. The reason for said emergency is the desire to have the bleachers removed as soon as possible in order to prepare the site for future development. Therefore, this ordinance shall become effective immediately.

VILLAGE OF EVENDALE, OHIO ORDINANCE #17-16

AN ORDINANCE ESTABLISHING FEES FOR THE RESIDENTIAL RENTAL PROPERTY REGISTRATION PROGRAM AND DECLARING AN EMERGENCY

- **WHEREAS,** the Village Council adopted a Residential Rental Property Registration Program in Chapter 1468 of the Evendale Municipal Code via Ordinance 16-78 on December 13, 2016; and
- **WHEREAS**, Evendale Municipal Code Section 1468.06 provides that the permit administration fees for the Residential Rental Property Program will be set by Village Ordinance; and
- **WHEREAS,** Evendale Municipal Code Section 1468.06(F), Residential Rental Property Registration permits are good for five (5) years or for each new occupancy, whichever is sooner; and
- **WHEREAS**, the Village Council has determined that there are administrative costs associated with administering the Residential Rental Property Registration Program; and
- **WHEREAS**, the Village Council has determined that there are administrative costs associated with administering the Residential Rental Property Registration Program; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

- **SECTION 1:** An application filed per Evendale Municipal Code Section 1468.06(A) shall be subject to an application fee of \$100 per residential rental property.
- SECTION 2: This ordinance is declared to be an emergency measure by a concurrence of five members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. The reason for said emergency is the immediate necessity to ensure that costs to administer the Residential Rental Property Registration program under Chapter 1468 are adequately covered. Therefore, this ordinance shall become effective immediately.
