AN ORDINANCE APPROPRIATING FUNDS FOR THE I-75 PROJECT, AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT WITH THE OHIO DEPARTMENT OF TRANSPORTATION AND DECLARING AN EMERGENCY

The following Final Ordinance is enacted by the Village of Evendale, Ohio , hereinafter referred to as the Legislative Authority/Local Public Agency or "LPA," in the matter of the stated described project.

WHEREAS,

on 14<sup>th</sup> day of April, 2015, the LPA enacted legislation proposing cooperation with the Director of Transportation for the described project:

The project consists of the reconstruction of IR 75 between Shepherd Lane and Glendale-Milford Road. The work includes the redesign of the Shepherd Lane Interchange, removal of the collector distributor system, aesthetics and improvements to the Glendale-Milford Road interchange, lying within the Village of Evendale.

WHEREAS, the LPA shall cooperate with the Director of Transportation in the above described as follows:

The Village agrees to assume and bear one hundred percent (100%) of the entire cost of the items requested by the village which are determined not to be eligible for Federal and State participation. In addition, the Village agrees to assume and bear one hundred percent (100%) of the cost difference for the higher priced alternates and one hundred percent (100%) of the cost of any additive alternates chosen.

The share of the cost of the LPA is now estimated in the amount of **Three Hundred Twenty Seven Thousand and Seventy and** ---- **00/100 Dollars, (\$327,070.00)**, but said estimated amount is to be adjusted in order that the LPA's ultimate share of said improvement shall correspond in with said percentages of actual costs when said actual costs are determined; and

WHEREAS, the Director of Transportation has approved said legislation proposing

cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of the same to this legislative authority; and

WHEREAS, the LPA desires the Director of Transportation to proceed with the

aforesaid highway improvement.

NOW, THEREFORE, be it ordained:

SECTION I. That the estimated sum of Three Hundred Twenty Seven

Thousand and Seventy and ---- 00/100 Dollars, (\$327,070.00), is hereby appropriated for the improvement described above and the Mayor is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from **Federal** funds.

SECTION II. That the LPA hereby requests the Director of Transportation to proceed

with the aforesaid improvement.

SECTION III. That the LPA enter into a contract with the State, and that Mayor be,

and is hereby authorized to execute said contract, attached hereto and incorporated by reference herein, providing for the payment of the LPA the sum of money set forth herein above for improving the described project.

SECTION IV. That the LPA transmit to the Director of Transportation a fully executed copy of this Resolution.

SECTION V. This ordinance is declared to be an emergency measure necessary to

preserve the health safety and general welfare of the village or to provide for the daily operation of a department or office of the Village. The reason for said emergency is so that the upgrades of I-75 can move forward as rapidly as possible for the safety of the motoring public. Therefore this ordinance shall take effect immediately.

SECTION V. The following items are authorized to be purchased on the State Bid List: Fire - Command Vehicle \$45,000, Radios/Base station \$80,000, Police- Cruisers and related equipment \$76,000, Recreation - Fitness Equipment \$75,700 and SCMR (Service) – Dump Truck Plow - \$46,000.

**SECTION 7:** This ordinance is declared to be an emergency measure by a concurrence of six members of Council, being necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency being the legal need to promptly forward the 2017 Appropriation Ordinance to Hamilton County authorities and shall therefore take effect and be in force immediately from and upon passage.

## ORDINANCE APPROVING TRANSFERRING GENERAL FUNDS TO VARIOUS OTHER FUNDS, AND DECLARING AN EMERGENCY

WHEREAS, PUSUANT TO LEGISLATION PROPERLY ADOPTED BY THE COUNCIL of the Village of Evendale, certain expenditures will take place that need to be appropriately funded by transfers from the General Fund to the specific funds from which expenditures will be made,

WHEREAS, THE BUDGET ADOPTED BY THE COUNCIL ON DECEMBER 13, 2016 FOR the 2017 fiscal year provides for said funding transfers; now,

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring that:

**SECTION 1:** The sum of \$500,000.00 is transferred from the General Fund to the Street Construction Repair and Maintenance Fund.

**SECTION 2:** The sum of \$100,000.00 is transferred from the General Fund to the Municipal Motor Vehicle Fund.

**SECTION 3:** The sum of \$5,570,000.00 is transferred from the General Fund to the Capital Improvement Fund.

**SECTION 4:** The sum of \$416,000.00 is transferred from the General Fund to the Gorman Heritage Farm Fund. The amount of \$350,000.00 is designated for operations and the \$65,000.00 is designated for capital improvements and \$1,000.00 is designated for fuel.

**SECTION 5:** The sum of \$150,000.00 is transferred from the Fire Services Fund to the General Fund. This amount is considered to be a partial repayment of an advance to the Fire Services Fund from the General Fund in 2016 for the purchase of a fire truck with the expectation that the Fire Services Fund will reimburse the General Fund until the \$450,000 is fully refunded which is approximated as four years.

**SECTION 5:** This ordinance is declared to be an emergency by a concurrence of six members of Council, being necessary to preserve the public peace, order, safety, health, or welfare of the Village of Evendale or to provide for the daily operations of a department or office of the Village of Evendale. It is necessary that this measure be put into effect immediately because the public welfare and daily operations of the Village require that line items within departmental budgets not exceed the appropriation amounts approved by Council. This ordinance shall be effective upon passage.

WHEREAS, the Village of Evendale Fire Department has acquired a new fire truck which

will replace the 1991 Sutphin pumper engine fire truck; and

WHEREAS, the neighboring Village of Lincoln Heights has stated a desire to acquire the

1991 Sutphin fire truck, which is no longer needed by the Village of Evendale,

for \$16,000; and

**WHEREAS,** the Village of Lincoln Heights has determined that the 1991 Sutphin fire truck

is better able to meet the needs of the Village of Lincoln Heights than is its

current equipment; and

WHEREAS, having the Village of Lincoln Heights be in a better position to provide

firefighting services will benefit the Village of Evendale when mutual aid assistance may be necessary from the Village of Lincoln Heights; now,

therefore.

## BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

#### **SECTION 1**:

The Mayor and Fire Chief are hereby authorized to take all steps necessary to transfer to the Village of Lincoln Heights the 1991 Sutphin fire truck pumper engine Model T5 4DR, Vehicle Vin No. 159A1BFDXM1003874, along with the equipment on the truck identified on the sheet attached hereto and incorporated by reference herein in exchange for the payment to the Village of Evendale of \$16,000.00 in a certified check, electronic transfer, or after notice from the bank that a non-certified check has cleared and the money is in a village of Evendale account. The transfer of the fire truck to the Village of Lincoln Heights is also conditioned upon Lincoln Heights signing an agreement that it is purchasing the truck and equipment in an asis condition with no warranties or guaranties whatsoever.

#### **SECTION 2**:

This ordinance is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. The reason for said emergency is to assist in addressing the immediate need of the Village of Lincoln Heights for better firefighting equipment which will directly benefit the Village of Evendale given that Lincoln Heights is an immediate neighbor with whom Evendale has reciprocal mutual aid agreements, and will make space available at the Village of Evendale Fire Department necessary for the adequate garaging of Evendale firefighting and EMS equipment. MODIFICATIONS TO THE DECLARATION OF COVENANT
GOVERNING THE EVENDALE BUSINESS PARK AND APPROVING
THE SUBDIVISION OF PROPERTY NECESSARY TO ALLOW THE
EXPANSION OF KINETIC INDUSTRIES AND THE CREATION OF
THE EVENDALE PARK AND DECLARING AN EMERGENCY

WHEREAS,

in order to promote the expansion of business and employment opportunities within the Village of Evendale, specifically with regard to Kinetic Vision, the Village of Evendale desires to complete an agreement with the businesses and property owners effected by that expansion; and

WHEREAS,

in order to complete this transaction, it is necessary for the Mayor to complete the negotiations of and consummate a contract which will provide for the Village to accept the donation of property which will be developed as a Village of Evendale park and agree to certain amendments to the current Declaration of Covenants, Conditions, Restrictions and Easements governing the Evendale Commons Business Park; now, therefore,

# BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

### **SECTION 1**:

The subdivision of property necessary for the expansion of Kinetic Vision, and the creation of an Evendale park that will be adjacent to the property owned by Dynamic Site Properties, Ltd. on which Kinetic Vision is located, such subdivision having been already approved by the Planning Commission of the Village of Evendale, is hereby approved. The plat of such subdivision is available in the Building Department for inspection.

#### **SECTION 2**:

The Mayor is hereby authorized to negotiate a final agreement with the necessary parties, including Evendale Commons, Ltd., the necessary occupants of Evendale Commons Business Park, specifically including Menards, Dynamic Site Properties, Ltd., and Kinetic Vision.

#### **SECTION 3**:

The Council of the Village of Evendale hereby specifically approves the acceptance of the donation of land necessary for the creation of an Evendale park adjacent to Kinetic Vision conditioned upon the approval of said donation by the Planning Commission of the Village of Evendale.

#### **SECTION 2:**

This ordinance is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. The reason for said emergency is the need to complete this transaction as soon as possible in order to promote the expansion of an Evendale business, thereby enhancing the economy of the Village of Evendale, promoting employment opportunities within the Village of Evendale and creating a new Village of Evendale park. Therefore, this ordinance shall become effective immediately.

**SECTION 1:** Effective from January 1, 2017, until December 31, 2017, the following are appointed as designated specialists in the Fire Department:

- A. Inspector Specialist, Unit 1, Andrew Wilfong
- B. Inspector Specialist, Unit 2, David Stark; and
- C. Inspector Specialist, Unit 3, Roger Neff and James McManus.

**SECTION 2:** Effective from January 1, 2017, until December 31, 2017, the following are appointed as designated specialists in the Police Department:

- A. Crime Prevention Specialist, Spec Kevin Akers
- B. Patrol Operations- Rick Vonderhaar
- C. A.L.I.C.E Instructor/ Tactical Specialist Spec Greg Titgemeyer
- D. Traffic Specialist, Spec Steve Roach
- E. Firearms Specialist, Spec Joel Ward
- F. Accreditation Specialist, Spec Tina McCormick

**SECTION 3:** Each specialist appointed by this Resolution shall receive additional compensation in addition to the salary otherwise paid to them in the amount of \$750 per year, which shall be paid in one lump sum with the first full paid period in December of 2017.

**SECTION 4:** Persons appointed to specialists positions designated in Sections 1 and 2 of this Resolution shall maintain their status in those positions until December 31, 2017, unless or until otherwise removed prior to that date by disciplinary action taken under personnel ordinances, or Village or Department rules and regulations.

SECTION 5: This Resolution is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operations of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect because the current specialist appointments expire December 31, 2017, and the new specialists need to be in place at the time of that expiration. Therefore, this resolution shall be effective upon passage.
