The following ordinances were opted by the Council of the Village of Evendale at the Regular Council Meeting on January 12, 2021.

ORDINANCE APPROVING TRANSFERRING GENERAL FUNDS TO VARIOUS OTHER FUNDS, AND DECLARING AN EMERGENCY. Unanimously approved

### VILLAGE OF EVENDALE, OHIO ORDINANCE #21-01

### ORDINANCE APPROVING TRANSFERRING GENERAL FUNDS TO VARIOUS OTHER FUNDS, AND DECLARING AN EMERGENCY

WHEREAS, PUSUANT TO LEGISLATION PROPERLY ADOPTED BY THE COUNCIL of the Village of Evendale, certain expenditures will take place that need to be appropriately funded by transfers from the General Fund to the specific funds from which expenditures will be made,

WHEREAS, THE BUDGET ADOPTED BY THE COUNCIL ON DECEMBER 8, 2020 FOR the 2021 fiscal year provides for said funding transfers; now,

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring that:

**SECTION 1:** The sum of \$800,000.00 is transferred from the General Fund to the Street Construction Repair and Maintenance Fund.

**SECTION 2:** The sum of \$416,000.00 is transferred from the General Fund to the Gorman Heritage Farm Fund. The amount of \$350,000.00 is designated for operations and the \$65,000.00 is designated for capital improvements and \$1,000.00 is designated for fuel.

**SECTION 3:** This ordinance is declared to be an emergency by a concurrence of five members of Council, being necessary to preserve the public peace, order, safety, health, or welfare of the Village of Evendale or to provide for the daily operations of a department or office of the Village of Evendale. It is necessary that this measure be put into effect immediately because the public welfare and daily operations of the Village require that line items within departmental budgets not exceed the appropriation amounts approved by Council. This ordinance shall be effective upon passage.

### VILLAGE OF EVENDALE, OHIO ORDINANCE #21-02

## ORDINANCE AUTHORIZING THE MAYOR TO HIRE MARK RIEDMILLER AS A PART-TIME BUILDING ATTENDANT FOR THE RECREATION DEPARTMENT AND DECLARING AN EMERGENCY

**WHEREAS**, the Council of the Village of Evendale has enacted Chapter 258 of the Codified Ordinances of the Village of Evendale, requiring authorization by Council for the Mayor to hire a part-time employee; and,

**WHEREAS**, the Mayor has recommended the hiring of Mark Riedmiller as part-time Building Attendant for the Recreation Department; and,

**WHEREAS**, the Mayor and the administration has fully complied with Section 260.06(a) of the Codified Ordinances of the Village of Evendale; now

### BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

**SECTION 1:** The following person may be employed, effective January 12, 2021 by the Mayor of the Village of Evendale as a part-time Building Attendant for the Recreation Department at an hourly rate established below:

Mark Riedmiller: Hourly Pay: \$11.00

**SECTION 2:** This ordinance is hereby declared to be an emergency measure by a concurrence of six members of the Village Council. The reason for said emergency is to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operations of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect in order to ensure that the Village Recreation Department has the staffing necessary to provide for and to perform its critical functions to the Village and its citizens. Therefore, this ordinance shall be effective upon passage.

# AN ORDINANCE RATIFYING THE MAYOR'S EXECUTION OF AN AGREEMENT WITH PEEL9 INC. TO PROVIDE A RECORDS MANAGEMENT AND ANALYTICS SYSTEM TO BE USED BY THE EVENDALE POLICE DEPARTMENT AND DECLARING AN EMERGENCY

WHEREAS,	the Police Chief has reported that the Police Department is in need of an improved records management and analytics system; and	
WHEREAS,	it is a benefit to the Village Police Department to be able to share certain records with other local law enforcement agencies in the area; and	
WHEREAS,	it is necessary that such a system is capable of incorporating historical police records as well as current records; and	
WHEREAS,	PEEL9 Inc. currently successfully provides all of these services to other local government police departments in the immediate area and can provide the same service for the Village of Evendale;	
WHEREAS,	Funds for the PEEL9 Inc. agreement have previously been approved and are in included in the Village Budget and the PEEL9 program and its benefits have been discussed with the Committee of Council overseeing the Police Department; now therefore	
	ED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE ix members concurring that:	
SECTION 1:	The Mayor's execution of an agreement substantially in the form attached hereto with PEEL9 Inc. which will provide the services generally described in the Whereas clauses above and in the contract and its exhibits attached hereto is hereby ratified and approved.	
SECTION 2:	This ordinance is hereby declared to be an emergency by a concurrence of six members of Council, measure necessary to preserve the health, safety and general welfare of the Village of Evendale and to provide for the daily operation of the Evendale Police Department. The reason for said emergency is the immediate need to have readily available, various police records to assist in law enforcement activities and the preservation of public peace and safety in the Village. Therefore, this Ordinance shall be effective immediately.
