ORDINANCE #17-38**

**AN ORDINANCE AMENDING THE EVENDALE CODE OF  
ORDINANCES PART TWELVE, TITLE TWO, FOR THE  
VILLAGE OF EVENDALE REGARDING THE NOW-HIRING  
SIGNS, AND DECLARING AN EMERGENCY.**

- WHEREAS,** The Evendale Zoning Code (“EZC”) regulates all signage in Chapter 1262 and defines various types of signs within that Chapter; and
- WHEREAS,** The EZC places varying area, quantity, time limit, and other limitations on signs depending upon the type of sign at issue; and
- WHEREAS,** Temporary signs are generally permitted to be posted on a property no longer than 30 days at a time; and
- WHEREAS,** Businesses within the Village have approached Village staff and expressed a desire to be able to post “now hiring” signage; and
- WHEREAS,** Representatives of those businesses have generally indicated that a hiring search extends beyond 30 days, causing the temporary signage time limitations to be impractical; and
- WHEREAS,** Planning Commission expressed a desire for ground mounted now hiring signs to be limited to a type that is of rigid material, more similar to a “short term” sign; and
- WHEREAS,** Planning Commission held a public hearing on the proposed amendments to the Zoning Code related to “Now-Hiring” signs on March 21, 2017; and
- WHEREAS,** Said modifications to the Zoning Code have been considered by the Planning Commission and recommended for adoption on April 18, 2017;
- WHEREAS,** The Council of the Village of Evendale has conducted a public hearing on the proposed modifications to the Zoning Code and finds that such changes will allow for a sound and practical policy regarding the usage of “Now Hiring” signs within the Village;

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:**

- SECTION I** Section 1262.03 of Part Twelve, Title Two, the Zoning Code of the Village of Evendale, is hereby amended to include the subparagraph (to be added where appropriate alphabetically) to read as shown on the attached Exhibit A, Amendment #1. The remainder of Section 1262.03 shall remain as-is.
- SECTION II** Schedule 1262.11 of Part Twelve, Title Two, the Zoning Code of the Village of Evendale, is hereby amended to include the subparagraph under “Temporary Signs” to read as shown on the attached Exhibit A, Amendment #2. The remainder of Schedule 1262.11 shall remain as-is.
- SECTION III** Schedule 1262.12 of Part Twelve, Title Two, the Zoning Code of the Village of Evendale, is hereby amended to include the subparagraph under “Temporary Signs” to read as shown on the attached Exhibit A, Amendment #3. The remainder of Schedule 1262.12 shall remain as-is.
- SECTION IV** Schedule 1262.13 of Part Twelve, Title Two, the Zoning Code of the Village of Evendale, is hereby amended to include the subparagraph under “Temporary Signs” to read as shown on the attached Exhibit A, Amendment #4. The remainder of Schedule 1262.13 shall remain as-is.

**SECTION V** Schedule 1262.14 of Part Twelve, Title Two, the Zoning Code of the Village of Evendale, is hereby amended to include the subparagraph under “Temporary Signs” to read as shown on the attached Exhibit A, Amendment #5. The remainder of Schedule 1262.14 shall remain as-is.

**SECTION VI** Section 1262.09(o), subparagraph (1) of Part Twelve, Title Two, the Zoning Code of the Village of Evendale, is hereby amended as shown on the attached Exhibit A, Amendment #6, and to add subsection 1262.09(o)(9).

**SECTION VII** This ordinance is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale. The reason for said emergency is to allow businesses to post now-hiring signs as needed to encourage and promote business in the Village. Therefore, this ordinance shall become effective immediately.

(1) All temporary Signs, excluding Now Hiring Signs, Banners, Political Signs, A-Frame Signs, Grand Opening Signs, and Pennants, Streamers balloons, festive device signs, or similar moving devices or air activated graphics, may be displayed for a period not to exceed 30 days for a maximum of four times a year for every calendar year with a minimum of 30 days between installations.

(9) Now-Hiring Signs. “Now Hiring Signs” which are ground mounted shall be made out of a rigid frame with a rigid sign face or faces.

**WHEREAS,** at its April 2017 meeting, the Council of the Village of Evendale adopted Ordinance #17-23, which authorized the Mayor to enter into a certain Real Estate Purchase Agreement with Felitto, Inc.; and

It is now appropriate to approve the revised Real Estate Purchase Agreement; now, therefore

**BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:**

**SECTION 1:** The Mayor is hereby authorized to execute the revised Real Estate Purchase Agreement substantially in the form attached hereto and incorporated by reference herein in order to proceed to acquire the Felitto, Inc. property on Glendale Milford Road. The remainder of Ordinance #17-23 remains in full force and effect.

**SECTION 2:** This ordinance is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of department or office of the Village of Evendale. The reason for said emergency is the need to proceed to acquire the Felitto property as soon as possible in order to assemble property for the AreoHub project. Therefore, this ordinance shall become effective immediately.

**AN ORDINANCE AUTHORIZING THE PAYMENT OF AMOUNTS DUE UPON  
CERTAIN CONTRACTS REQUIRING CERTIFICATION OF AVAILABILITY OF  
FUNDS AND DECLARING AN EMERGENCY.**

**WHEREAS,** Ohio Revised Code 5705.41(D)(1) provides that where contracts have not been previously certified for sufficient funds being available, Village Council may authorize the drawing of warrants to pay such contracts upon receipt of a certificate from the fiscal officer stating that there was at the time of the making of such contract or order and at the time of the execution of such certificate, a sufficient sum appropriated for the purpose of such contract and in the treasury or in the process of collection to the credit of an appropriate fund free from any previous encumbrances, and

**WHEREAS,** Certain contracts enumerated below are now due and payable for which such a certificate has been provided by the Chief Fiscal and Accounting Officer;

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:**

**SECTION I** The Council of the Village of Evendale hereby approves and authorizes the payment of the following contracts for which the Chief Fiscal and Accounting Officer has provided a certificate that a sufficient sum has been appropriated for the purpose of each contract and is in the treasury or in the process of collection to the credit of the appropriate fund free from any previous encumbrances:

**ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT  
WITH ANTHEM TO PROVIDE A COMPREHENSIVE HEALTH INSURANCE  
BENEFIT TO FULL TIME VILLAGE EMPLOYEES AND DECLARING AN  
EMERGENCY.**

**WHEREAS,** It is the intention of the Council of the Village of Evendale to offer quality health insurance coverage to full time Village employees; and

**WHEREAS,** Evendale's Health Insurance Review Team (HIRT), and HORAN, Evendale's Health Insurance Broker, have solicited and received the ERC Health renewal rate;

**WHEREAS,** The Village's current health insurance contract with Anthem expires June 20, 2017;

**WHEREAS,** After considerable review and analysis of plan design options and third party administration operations, The HIRT Committee recommends continuing with the Lumenos HSA Option E1 with Rx CE plan design ("The Lumenos Plan") offered by Anthem; and

**WHEREAS,** Enrollment in the Lumenos Plan would result in a 8.5% increase over the current premium rate for a 12 month term; and

**WHEREAS,** The Mayor and Village Council encourage and support employees engaged in wellness activities and other plan components that positively impact future premium costs

**BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:**

**SECTION 1:** The Mayor is hereby authorized to enter into a contract with Anthem for medical insurance and related coverage for Village employees in the form of coverage known as the Lumenos Plan, said plan being summarized in Attachment A.

**SECTION 2:** The Mayor is hereby authorized to enact the plan's wellness component known as the ERHealth Academy.

**SECTION 3:** Council has determined that incentivizing proactive employees is an important part of an effective wellness program proven to help control health care costs, specifically premium rates, and improve employees' health, morale, and productivity. To encourage maximum proactive participation by employees and spouses, Village Council will provide an employee premium reduction AND a health savings account contribution as follows:

Required Activities to Qualify for Incentive

- Employees and spouses are to complete an annual preventive care screening/physical and properly submitting the provided form(s) during the Annual Preventive Care Campaign; and
- Employees are to meet with a provided onsite wellness coach at least four (4) times OR employees are to attend at least four (4) wellness educational training sessions as provided by the Wellness Committee OR a combination of both to equal four (4) total sessions/meetings between January 1, 2018 and December 31, 2018.

Premium and Health Savings Account Contributions

- All employees who meet both of the above requirements within the plan year in respectively will have their Village required premium contribution reduced by 25 percent.
- All employees who meet both of the above requirements in each renewal period will have the Village’s health savings account contribution increased by 25 percent.
- This would make the effective employee contribution rates as follows:

**SECTION 4:** This ordinance is declared to be an emergency measure by a concurrence of six members of Council. It being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. The reason for said emergency is the necessity to enter into a contract prior to the expiration of the existing medical insurance coverage which expires on June 20, 2017. Therefore, in order to provide ongoing medical and related coverages to the employees of the Village of Evendale and their families, this ordinance shall take effect immediately.

**AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH OHIO PLAN RISK MANAGEMENT, INC. TO PROVIDE PROPERTY AND LIABILITY INSURANCE WITH THE ASSISTANCE OF HYLANT ADMINISTRATIVE SERVICES FOR THE VILLAGE OF EVENDALE AND DECLARING AN EMERGENCY.**

**WHEREAS,** With the assistance of the Hylant Administrative Services, the Village of Evendale has obtained a proposal to continue to obtain property and liability insurance through the Ohio Plan Risk Management Program, a joint self-insurance pool; and

**WHEREAS,** Pursuant to the provisions of the Ohio Revised Code Section 9.833 and 2744.081, it is not necessary for the Village of Evendale to seek competitive bids for such insurance when the insurance is being provided through a joint self-insurance pool addressing the needs of political subdivisions; and

**WHEREAS,** The Village's current coverage is due to expire on July 1, 2017. Current coverage will continue under previous plan until a new plan is approved.

**NOW THEREFORE,**

**BE IT ORDAINED** by the Council of the Village of Evendale, State of Ohio, six members concurring that:

**SECTION 1** The Mayor is hereby authorized to enter into such contracts as may be necessary to ensure that the Village remains covered by property and liability insurance as provided by Ohio Plan Risk Management, Inc. and to utilize the services of Hylant Administrative Services to secure, evaluate and monitor such insurance. Such insurance to be provided as described on the Ohio Plan Risk Management application attached hereto and incorporated by reference herein.

**SECTION II** This Ordinance is hereby declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale and its citizens and/or to provide for the daily operation of a department or office of the Village of Evendale. The reason for said emergency is that the Village needs to have continual insurance coverage and the current coverage is due to expire at the end of June.

**THEREFORE,** this Ordinance shall become effective immediately.

**ORDINANCE AUTHORIZING MAYOR TO HIRE  
SEASONAL EMPLOYEES AND SETTING PAY RATES  
AND DECLARING AN EMERGENCY**

**WHEREAS**, the Council of the Village of Evendale has enacted Chapter 260 of the Codified Ordinances of the Village of Evendale requiring authorization by Council for the Mayor to hire seasonal employees; and,

**WHEREAS**, the Mayor has submitted a list of seasonal employees who may be employed for a particular season or seasons.

**WHEREAS**, the Mayor has fully complied with Section 260.06(a) of the Codified Ordinances of Evendale and recommended that Council authorize the hiring of the individuals specified below for seasonal positions for which employment is authorized by this ordinance.

**BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring that:**

**SECTION 1:** The following person may be employed during a particular season or seasons by the Mayor of the Village of Evendale as Seasonal Employees at the hourly rate or lump sum rate established for each person by this Ordinance:
