The following ordinances were opted by the Council of the Village of Evendale at the Regular Council Meeting on March 15, 2022.

ORD #22-17 AN ORDINANCE APPROVING AN ADDITIONAL APPROPRIATION IN THE COURT COMPUTER FUND AND DECLARING AN EMERGENCY. Unanimously Approved

ORD #22-18 ORDINANCE MAKING AN ADDITIONAL BUDGET APPROPRIATION FOR THE ARPA FUND FOR THE FISCAL YEAR ENDING DECEMBER 31, 2022 AND DECLARING AN EMERGENCY. Unanimously Approved

VILLAGE OF EVENDALE, OHIO ORDINANCE #22-17

AN ORDINANCE APPROVING AN ADDITIONAL APPROPRIATION IN THE COURT COMPUTER FUND AND DECLARING AN EMERGENCY

- **WHEREAS**, Pursuant to legislation properly adopted by the Council of the Village of Evendale, certain expenditures will take place that need to be appropriately reflected as appropriations; and
- **WHEREAS,** Coordination between various software within the Mayor's Court must be designed and implemented; and
- WHEREAS, Funds are available in the Court Computer fund; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

SECTION I The following sums are appropriated from the unappropriated Court Computer Fund (204) to the following line:

204.703.524200 Operating Expense \$2,500.00

SECTION II This ordinance is declared to be an emergency by a concurrence of six members of Council, being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale or to provide for the daily operations of a department or office of the Village of Evendale. It is necessary that this measure be put into effect immediately because the public welfare and daily operations of the Village require that line items within special revenue fund budgets not exceed the appropriation amounts approved by Council and it is in the public interest for the Village Mayor's Court to be able to coordinate use of the various software systems supporting the Mayor's Court to gain efficiency and effectiveness. This ordinance shall be effective upon passage.

VILLAGE OF EVENDALE ORDINANCE # 22-18

ORDINANCE MAKING AN ADDITIONAL BUDGET APPROPRIATION FOR THE ARPA FUND FOR THE FISCAL YEAR ENDING DECEMBER 31, 2022 AND DECLARING AN EMERGENCY

WHEREAS, it is necessary to make an appropriation to the ARPA Fund for the reallocation of funding;

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring that:

SECTION 1: The purpose of the ordinance is to provide for current expenditures of the Village of Evendale during the fiscal year ending December 31, 2022 related to the reallocated ARPA funding,

<u>SECTION 2</u>: The following sums are appropriated from the unappropriated ARPA Fund to the following objects:

ARPA Fund 230210-219Salaries and Fringe Benefits\$ 570.20

The associated revenue accounts budgeted for the ARPA Fund are as follows:

ARPA Fund 230 230.000.412000 ARPA Funds \$570.20

SECTION 3: The Chief Fiscal and Accounting Officer is hereby authorized to draw warrants on the Village Treasury for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, or any ordinance or resolution of Council to make the expenditure; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law, or ordinance.

SECTION 4: The funds appropriated for salaries pursuant to this ordinance shall be paid in accordance with the **2022 Salary Schedule** previously approved for the 2022 Fiscal Year.

<u>SECTION 5:</u> This ordinance is declared to be an emergency measure by a concurrence of -- members of Council, being necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency being the legal need to promptly forward the updated Appropriation Ordinance to Hamilton County authorities and shall therefore take effect and be in force immediately from and upon passage.

VILLAGE OF EVENDALE, OHIO ORDINANCE #22-19

AN ORDINANCE AUTHORIZING THE PAYMENT OF AMOUNTS DUE UPON CERTAIN CONTRACTS REQUIRING CERTIFICATION OF AVAILABILTY OF FUNDS AND DECLARING AN EMERGENCY.

- WHEREAS, Ohio Revised Code 5705.41(D)(1) provides that where contracts have not been previously certified for sufficient funds being available, Village Council may authorize the drawing of warrants to pay such contracts upon receipt of a certificate from the fiscal officer stating that there was at the time of the making of such contract or order and at the time of the execution of such certificate, a sufficient sum appropriated for the purpose of such contract and in the treasury or in the process of collection to the credit of an appropriate fund free from any previous encumbrances, and
- **WHEREAS,** Certain contracts enumerated below are now due and payable for which such a certificate has been provided by the Chief Fiscal and Accounting Officer;

NOW STHEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

- **SECTION I** The Council of the Village of Evendale hereby approves and authorizes the payment of the following contracts for which the Chief Fiscal and Accounting Officer has provided a certificate that a sufficient sum has been appropriated for the purpose of each contract and is in the treasury or in the process of collection to the credit of the appropriate fund free from any previous encumbrances:
 - 1) Kaffenbarger Truck Repairs \$4,000.00
- **SECTION II** This Ordinance is declared to be an emergency by a concurrence of six members of Council, being necessary to preserve the public peace, order, safety, health and welfare of the Village or to provide for the daily operation of a department or office of the Village. The reason for said emergency is the need to approve this ordinance in the time required by the Ohio Revised Code and to ensure prompt payment to vendors. Therefore, this Ordinance shall be effective upon adoption.
