ORDINANCE APPOINTING STEVE NIEHAUSER AS ASSISTANT CHIEF OF THE EVENDALE POLICE DEPARTMENT AND DECLARING AN EMERGENCY

- **WHEREAS,** having been hired in December of 1990, Lieutenant Steve Niehauser has served with distinction for over thirty years as a member of the Evendale Police Department; and
- **WHEREAS,** promoted to Sergeant in 1998, most recently he has served for more than ten years, as a Lieutenant in the Police Department; and
- **WHEREAS,** in recognition of his service Niehauser shall henceforth hold the rank of Assistant Chief. Said rank shall be at the same pay as his current position as Lieutenant;
- **WHEREAS,** as Assistant Chief he shall serve as the Officer in Charge in the absence of the Chief and will be well positioned to serve as a mentor to the two recently appointed Lieutenants, now therefore,

BE IT HEREBY ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring that:

SECTION 1: Lieutenant Steve Niehauser shall henceforth hold the rank of Assistant Chief within the Evendale Police Department with same hourly pay as in his current rank as Lieutenant. The rank of Assistant Chief shall only be on the table of organization of the Evendale Police Department until the retirement of Assistant Chief Niehauser

SECTION 2: This ordinance is hereby declared to be an emergency by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health and general welfare of the Village of Evendale or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect in order that the command staff of the Village of Evendale Police Department clearly describe who is the officer in charge in the absence of the Police Chief. Therefore, this ordinance shall be effective immediately.

VILLAGE OF EVENDALE, OHIO ORDINANCE # 21-05

AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF THE VILLAGE OF EVENDALE TO CHANGE THE IF-2, INDUSTRIAL FLEX 2 ZONING TO A PUD-ID, INNOVATION DISTRICT PUD ZONING DESIGNATION ON PARCEL 611-0050-0066, AND DECLARING AN EMERGENCY.

WHEREAS, the Village adopted the "AeroHub Innovation District Master Plan" ("AeroHub Plan") for the AeroHub Site which includes area adjacent to the subject parcel; and

WHEREAS, In support of AeroHub, Evendale has already spent over \$10,000,000 acquiring property and developing roads and other infrastructure for a workforce development, R&D, high tech, advanced manufacturing focused commercial/industrial district in conformance with the AeroHub Plan, that infrastructure work includes a recently completed new boulevard style road providing access for Parcel No. 611-0050-0066 to and from Glendale Milford Road; and

WHEREAS, Chapter 1256 of the Evendale Zoning Code currently includes an "Innovation District PUD" (PUD-ID). To date, 50+/- acres adjacent to, and in the immediate vicinity of, Parcel No. 611-005-0066 have already been zoned PUD-ID with new development already completed in the PUD consistent with the AeroHub Plan; and

WHEREAS, the Village found it necessary and appropriate to consider expanding the PUD-ID, zoning designation to 5 parcels, including Parcel No. 611-0050-0066, adjacent to other property already so zoned in order to promote future redevelopment consistent with the AeroHub Plan; and

WHEREAS, The Planning Commission advertised for, provided the proper public notice and conducted a public hearing on the proposed rezoning of the 5 parcels on August 16, 2020 at which time counsel for the owner of Parcel No. 611-0050-0066, appeared and requested additional time to consider the matter before offering comment. The Planning Commission honored that request and held the matter to its September 2020 meeting. Counsel for the property owner again informally requested a delay and again the Planning Commission honored that request; and

WHEREAS, the Planning Commission on October 20, 2020, having provided ample time for comment, unanimously recommended to Village Council that that all 5 parcels, including Parcel No. 611-0050-0066, be rezoned to the PUD-ID, zoning designation; and

WHEREAS, Village Council advertised for, provided the proper public notice and held a public hearing on the Commission's recommendation at its meeting on November 11, 2020 and held the ordinance after doing a first reading to provide additional time for comment and consideration; and

whereas, shortly before its December Council meeting the Village Council received a letter dated December 4, 2020 from counsel for the owner of Parcel No. 611-0050-0066 objecting to the rezoning of that parcel. In order to provide time to consider that letter while moving forward with the rezoning of the other parcels, Council amended what became Ordinance No. 20-80 to remove Parcel No. 611-0050-0066 with the understanding that Parcel would be further considered at a later date: and

WHEREAS, having considered the December 4, 2020 letter Council notes that the letter fails to recognize that the current use of Parcel No. 611-0050-0066 is consistent with

and in compliance with the proposed rezoning: the Parcel is currently leased to GE Aviation and the building on the property houses various high tech equipment used to x-ray, test and/or otherwise evaluate aircraft engine parts as well as other equipment; and

WHEREAS,

the suggestion in the December 4, 2020 letter that the owner may desire to use the Parcel No. 611-0050-0066 for warehouse or general manufacturing purposes would conflict with the goals of the AeroHub Innovation District Master Plan; and

WHEREAS,

the Council of the Village of Evendale finds it appropriate to amend the Official Zoning Map of the Village of Evendale to change the zoning from IF-2, Industrial Flex 2 and extend PUD-ID, Innovation District PUD, on the subject Parcel No. 611-0050-0066 to effectuate planning and development goals set forth in the AeroHub Innovation District Master Plan which would be consistent with the zoning now in effect on adjacent properties; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

SECTION 1:

The Official Zoning Map of the Village of Evendale shall be amended to place a PUD-ID, Innovation District PUD zoning designation and remove the IF-2, Industrial Flex-2 zoning designation on the following listed parcel and as illustrated in Exhibit 1:

611-0050-0066

SECTION 2:

This ordinance is declared to be an emergency measure by a concurrence of five members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. The reason for said emergency is to enact zoning regulations to effectuate the planning goals of the Village and the AeroHub Innovation District Master Plan as soon as possible thereby encouraging the redevelopment of property and improving the economy of the Village. Therefore, this ordinance shall become effective immediately.

WHEREAS,

Ohio Revised Code 5705.41(D)(1) provides that where contracts have not been previously certified for sufficient funds being available, Village Council may authorize the drawing of warrants to pay such contracts upon receipt of a certificate from the fiscal officer stating that there was at the time of the making of such contract or order and at the time of the execution of such certificate, a sufficient sum appropriated for the purpose of such contract and in the treasury or in the process of collection to the credit of an appropriate fund free from any previous encumbrances, and

WHEREAS,

Certain contracts enumerated below are now due and payable for which such a certificate has been provided by the Chief Fiscal and Accounting Officer:
