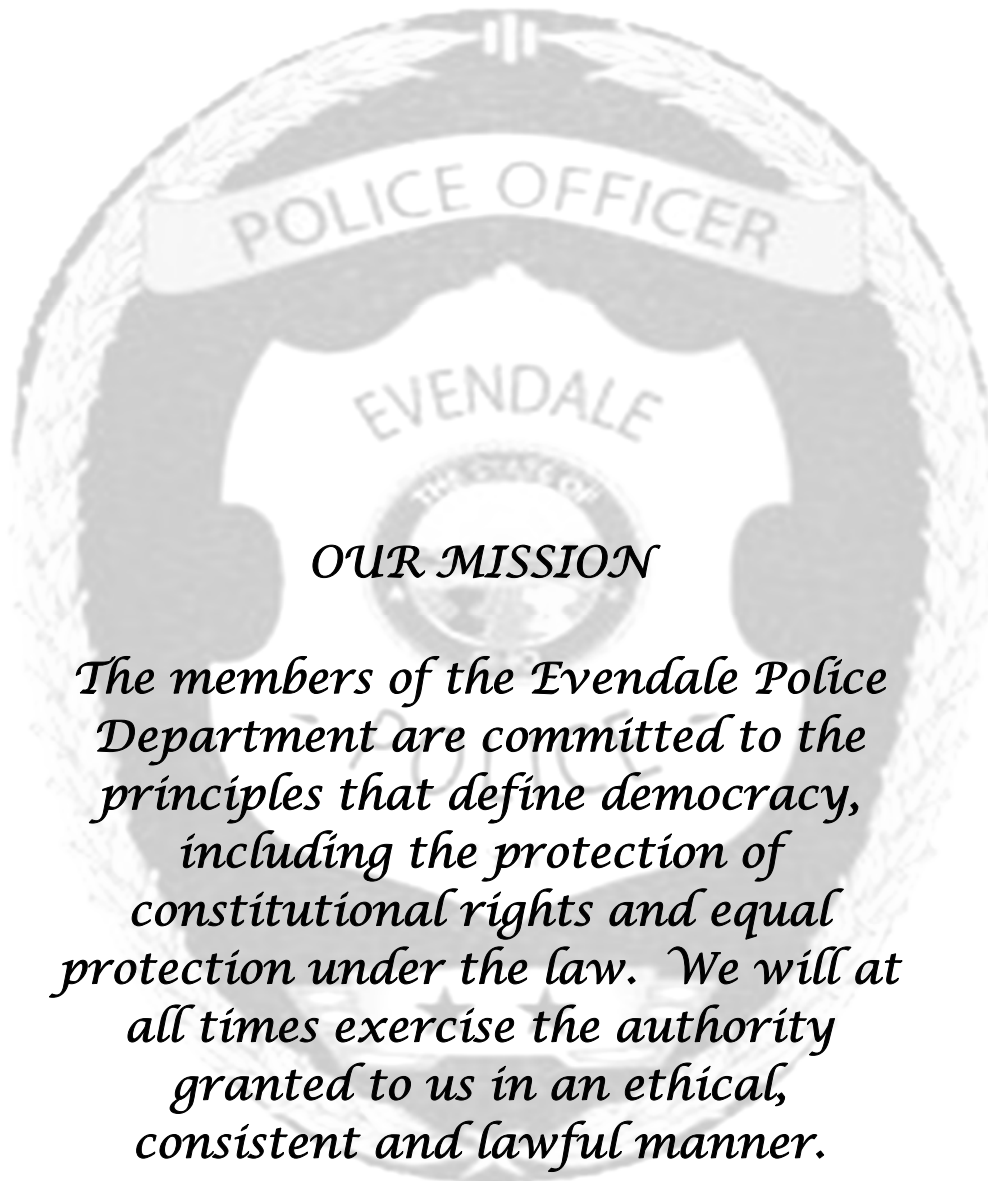


EVENDALE POLICE DEPARTMENT COUNCIL REPORT

OUR MISSION

The members of the Evendale Police Department are committed to the principles that define democracy, including the protection of constitutional rights and equal protection under the law. We will at all times exercise the authority granted to us in an ethical, consistent and lawful manner.

RECEIVING STOLEN PROPERTY

On 4/4, while on routine patrol, officers ran the plate of a Ford F 350 with the tag coming back as stolen. Officers conducted a traffic stop. The driver was taken into custody and found to have multiple warrants. A piece of paper in the suspect's front pocket was found containing suspected fentanyl. Charges pending lab results. Case closed by arrest.

BREAKING & ENTERING

On 4/20, officers responded to Sports Plus reference a breaking and entering in progress. The suspect damaged two ATM machines inside the business and successfully extracted cash money from the machine located near the entrance. The ATM near the rear of the business was damaged, but no cash money was taken. Case is under investigation.

THEFT

On 4/4, officers were dispatched to Sports Plus for a theft report. Victim stated her Nintendo 3DS Galaxy was taken during volleyball practice. Case is under investigation.

On 4/7, officers were dispatched to Walmart reference a possible theft. The suspect was seen pushing out a grocery cart full of items not in bags. The suspect was asked for a receipt for the merchandise but refused and fled the scene in her vehicle. Total value of merchandise \$141.01. Case is under investigation.

On 4/10, officers were summoned to Walmart for a possible theft in progress. The suspects were alleged to have made entry into a locked display case in the jewelry department where four empty boxes were located. No jewelry was found on either suspect. It was later determined \$144 in earrings and pendants were removed from the display counter. Investigation pending.

On 4/12, officers responded to Walmart for a theft subject being

detained. Walmart Loss Prevention observed the subject conceal two packs of men's socks and tried to leave the store without paying for the merchandise. Subject admitted to the theft. Total value \$19.68. Case closed by arrest.

On 4/14, officers responded to Walmart for a shoplifter being detained. Walmart Loss Prevention observed the suspect conceal grocery and automotive items valued at \$59.79 in a blue diaper bag. Subject then tried to leave the store without paying for the concealed merchandise. Case closed by arrest.

On 4/15, officers responded to Walmart for a shoplifter being followed by Walmart Loss Prevention. The suspect concealed items down the front of his pants and went past the last point of sale without paying for the merchandise valued at \$104.98. Suspect was found to have several warrants for his arrest and one which was through Evendale Police Department for a prior theft from Walmart. Subject charged with theft and transported to Hamilton County Justice Center. Case closed by arrest.

On 4/16, officers were dispatched to Walmart for a theft that had just occurred. Suspect concealed \$79.73 in merchandise and attempted to leave the store. Suspect cited to Mayor's Court and released.

On 4/20, Walmart Loss Prevention called the station to report they had a subject in the security office for theft. The suspect advised he had not paid for \$155.89 of merchandise in question. Loss Prevention stated the suspect had removed packaging from numerous small items and placed them in his pockets and passed the last point of sale without paying. Suspect was charged with theft and released. Case closed by arrest.

On 4/26, officers responded to a residence on Otterbein for a theft

report. Victim parked his motorcycle on the driveway with two helmets, one white jacket and gloves with the keys inside. The victim went inside to take a quick shower and once he came back outside, the motorcycle and all were gone. Victim did not see direction of travel. Investigation pending.

CRIMINAL DAMAGING

On 4/23, the complainant responded to the station to file a criminal damaging report. According to the complainant, the company bus was parked and untended on the lot of GE near gate #6 on 4/7/18. When company officials returned on 4/9/18 they discovered four of the windows on the bus were completely broken out or cracked. Total damage to the bus amounted to \$560.00. No known suspects at the time of the report. Case status suspended inactive pending any additional investigative leads.

On 4/30, officers responded to the area of Silco Fire Service on Medallion Drive reference a suspicious male walking in the rear of the business. Moments later, the subject was located spray painting graffiti on the silo at 2885 E. Sharon Road. The subject was identified and released. Criminal charges are pending. The victim requested an opportunity to review the graffiti in person. Case status will remain open.

DRUG ABUSE

On 4/16, while on routine patrol, a vehicle query returned a traffic capias out of Hamilton County Central Warrants. Officers initiated a traffic stop and noticed a strong smell of burnt marijuana coming from the vehicle. The driver was found to have a suspended driver's license. The passenger was found to have an active warrant out of Evendale and a burnt marijuana roach on her person. Both subjects were cited and released. Case closed by adult arrest.
