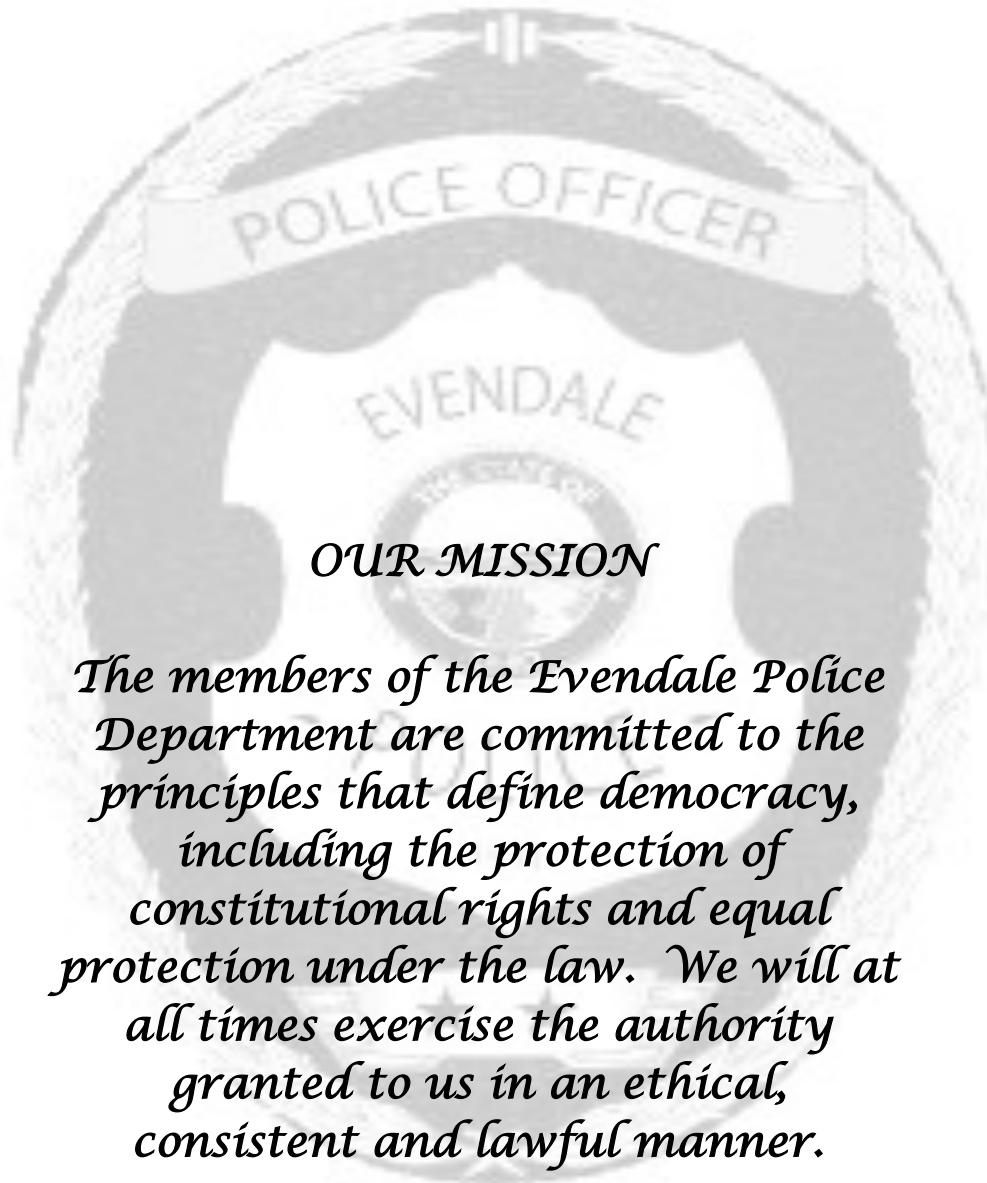


# EVENDALE POLICE DEPARTMENT COUNCIL REPORT

JANUARY 2024



## *OUR MISSION*

*The members of the Evendale Police Department are committed to the principles that define democracy, including the protection of constitutional rights and equal protection under the law. We will at all times exercise the authority granted to us in an ethical, consistent and lawful manner.*

### ***PROPERTY DAMAGE***

On 1/21/24 at 1536 hours, complainant called the PD reference property damage to her 2017 Kia Forte, that occurred the night prior on 1/20/24 at around 2200 hours. Subject stated she was the passenger in her car traveling Northbound on Reading Rd approaching 10100 Reading. A vehicle, involved in a pursuit by another jurisdiction, began to approach her from the rear at a high rate of speed. The driver of the subject's vehicle had to make an evasive maneuver to avoid being struck. This caused the complainant's vehicle to strike the median island, causing damage to the vehicle's two driver's side tires. Subject then parked her damaged vehicle in the lot of 10199 Reading Rd for the night because it was not drivable. Non-criminal report.

### ***ASSAULT***

On 1/3/24 at 0810 hours, Officers were dispatched to 2801 Cunningham Drive for a report. Victim stated that while shopping in Walmart, he came into contact with some individuals that he had problems with at the Red Roof Inn Sharonville. Victim states that one of the individuals attacked him and took him to the ground. Suspect stated that he felt that the victim was going to strike his dad, and that he felt his dad had been disrespected. Victim stated that he did not wish to prosecute at this time.

On 1/12/2024 at 1000 hours, Officers were dispatched to the Kidd Center at 9910 Reading Rd for trouble between employees who were involved in a fight just minutes prior. According to the caller, the parties had been separated by other staff members. Once on scene, complainant stated that there were two incidents between a total of four employees, where employees were involved in some sort of physical fight after a verbal argument. After obtaining written statements from all the parties involved in the fight, and 11 other employees who witnessed the incident, it was determined that no one saw either party

punch the victim(s). Case closed due to no independent witness verification of an assault to the victim.

On 1/14/2024 at approximately 1000 hours, Officers responded to Auto Zone at 10825 Reading Road for an assault report. Upon arriving on scene, Officers spoke with the victim who stated she was just assaulted by her boyfriend. The victim stated they had an argument over some text messages on her boyfriend's phone which resulted in him striking the victim in the face with a closed fist. Victim had a small cut on her chin as a result of the strike and was transported to the hospital by Evendale Medic 40 for treatment. Victim refused to press charges. Case closed. Prosecution declined.

### ***THEFT***

On 1/1/24 at 1720 hours, Officers responded to Menards for a theft report. Reportee stated suspect walked into Menards and Walmart taking various merchandise items, then walked past all points of sale without purchasing the merchandise. Suspect attempted to hide the merchandise outside in front of Walmart. Suspect also had several open warrants out of Blue Ash, Butler County Sheriff's Office and Hamilton County Sheriff's Office. Officer's were able to identify suspect via surveillance footage from Menards and placed him under arrest without further incident. Case closed adult arrest.

On 1/22/24 at 1300 hours, Officers responded to Walmart for a theft report. Walmart Loss Prevention observed a subject collecting receipts from the parking lot. She then took items off the shelf in the store fraudulently refunding the items for cash with one of the receipts she collected. The subject was located and cited for theft. Total value of theft \$35.59 in US currency. Case closed by adult arrest.

On 1/26/24 at 1120 hours, Officers were dispatched to Walmart for a shoplifter being held in the loss prevention office. Suspect was ob-

served concealing two Samsung phone cases valued at \$25.96 in his backpack and then attempted to leave the store without paying for the merchandise. Officers read suspect his Miranda rights where he admitted to the theft and stated he wasn't thinking. Subject had plenty of cash on his person to pay for the items. Suspect cited and released.

### ***MISUSE OF CREDIT CARD***

On 1/4/24 at 1935 hours, On the listed date and time, the victim responded to the police department to file a stolen credit card report. The victim stated that she was at the Customer Service desk of Walmart on 1/3/24 around 1930 hours. When she was finished she stated that she either left her wallet on the counter of the Customer Service desk when she left or dropped it while leaving the store, but was not completely sure. When she returned to the store on 1/4/24, she stated that her purse was sitting on the desk at Customer Service. She stated that everything was in her purse still except two credit cards were missing. The victim stated that she then canceled both credit cards, but stated the suspect used her card for two separate charges totaling around \$500.00. The victim stated she needed a police report for the credit card company to dismiss the charges on her card.

### ***CRIMINAL TRESPASS***

On 1/3/24 at 1016 hours, Officers were called to 1 Neumann Way for an unknown subject on the property. The subject was observed by GE Security crossing/climbing the fence into the facility and taking a pipe like object and crossing back over leaving the property toward Shepherd Avenue. The subject was located on West Columbia Ave. by Reading and Lockland Officers. Suspect was positively identified by GE Security and no GE property was located with him. GE Security Manager did not wish to prosecute the incident at this time.
