OUR MISSION

FORGERY

On 2/2, officers responded to Associated Vending in reference to a forgery report to supplement a recent arrest made by Blue Ash PD. Associated Vending stated they had mailed some checks. One of the checks mailed out had at some point been intercepted by an unknown subject. The check was forged by changing the name and amount paid from \$667.32 to \$3,350.56. The suspect was arrested at the Fifth Third in Blue Ash attempting to cash the forged check. Case closed by arrest (Blue Ash PD).

USING WEAPONS WHILE IN-**TOXICATED**

On 12/4, during a biker party being held at UAW, 10708 Reading Road, a large group of people were arguing and it appeared that it was becoming physical. As more officers were called to the scene to disperse the crowd, 3-4 shots were heard fired. The suspect was a male black holding his hand in the air with what appeared to be a gun and walking away from the crowd. The suspect was stopped and arrested. He was found to have a BAC of .172. Suspect charged with Inciting Violence and Using Weapons while Intoxicated. Suspect transported to Hamilton County Justice Center. Case closed by arrest.

MISUSE OF CREDIT CARD

On 2/17, victim came to the station to report his wallet and checkbook stolen from his place of employment at Story Book Kids. Victim stated he placed his bag containing his wallet and checkbook on the counter. At the end of his shift he noticed his wallet was no longer in his bag. He called to cancel his credit card and was informed that it had been used at a gas station in Monroe, OH in the amount of \$29.08. Case is under investigation.

On 2/17, victim called the station to report someone used her credit card for a purchase at Walmart. An

unknown person ordered a 50 inch Visio TV on line valued at \$425.86 using the victim's American Express card. The credit card was cancelled and Walmart was contacted about the fraudulent charge. Walmart, American Express and the complainant did not incur a loss due to the early detection of the card holder. Case closed exceptional means.

THEFT

On 2/1, officers were dispatched to Walmart reference a theft that just occurred. The suspect had a 65 inch Sharp TV valued at \$698.00 and passed all points of sale without paving. Once stopped, the suspect ran out of the store without the TV. Case is under investigation.

On 2/6, Corporate Security for Jurgensen contacted the station to report an unknown persons at an unknown time took the tires and rims from a sign board placed on the shoulder of the highway near the 13.5 mm on I-75. The value of the items stolen is \$100. There are no suspects or witnesses. Case is suspended inactive.

On 2/9, Walmart contacted the police department to report a theft have eight syringes in her purse, of \$1,521.62 worth of Go Pro merchandise. The unknown suspect used a crow bar from the hardware department to break open the acrylic Go Pro case. Case is currently under investigation.

On 2/10, officers were dispatched to the parking lot of Northland Ice Rink for two thefts from vehicles parked there. In each case, the vehicles had a window smashed in and a purse was taken. Victims were advised to cancel or put a stop on all credit and bank cards. Case is suspended inactive pending any new leads.

On 2/13, officers were dispatched to Walmart for a theft that just occurred. The suspect was observed

concealing items in her purse and in Walmart bags. Suspect cited to Evendale Mayor's Court and released. Theft amount \$279.56. Case closed by arrest.

On 2/22, officers were dispatched to Walmart for a theft that had just occurred. The suspect had selected a large amount of ladies clothing and a tote bag and passed all points of sale without paying. The items were valued at \$163.19. Subject cited to Mayor's Court and released. Case closed by arrest.

LOST/STOLEN PROPERTY

On 2/20, complainant called the station to advise after visiting the BMV in Sharonville and going to Walmart, his birth certificate and social security card were lost/ stolen. It's possible that due to high winds that day, the items may have blown out of his vehicle. Walmart was notified but nothing has been turned in. Case suspended inactive.

DRUG ABUSE

On 2/12, officers were dispatched to Speedway for a person passed out in the vehicle at the gas pump. The subject was found to two drug scales and 40 unit doses of LSD. Subject was arrested for possession of drugs and drug paraphernalia and transported to the Justice Center. Case closed by arrest.

On 2/23, officers were dispatched to Rest Haven Cemetery for a suspicious black pick up truck parked in the cemetery. The caller indicated the occupants of the truck appeared to be passed out or overdosed. The suspects were found to have several syringes and other drug paraphernalia. Both suspects had open warrants and were charged with possession of drug abuse instruments and paraphernalia. Case closed by adult arrests.
