OUR MISSION

The members of the Evendale Police Department are committed to the principles that define democracy, including the protection of constitutional rights and equal protection under the law. We will at all times exercise the authority granted to us in an ethical, consistent and lawful manner.

PROPERTY DAMAGE

On 2/19/24 at 1607 hours, Officers responded to Pro-Clean car wash. located at 10199 Reading Rd, to investigate three vehicles being damaged inside the car wash conveyor belt area. The driver of the first car stepped on her vehicle brakes causing her Chevy Traverse to stop on the conveyor belt making the Dodge Durango strike her Chevy Traverse. That incident made both vehicles come to a complete stop on the conveyor belt causing the third car, a Honda Pilot to strike the Dodge Durango. Vehicles were able to moved out of the conveyor belt area with minimum damage to all vehicles and no damage to Pro-Clean equipment. Case closed.

BREAKING & ENTERING

On 2/5/24 at 1530 hours. Officers were dispatched to Sichuan Chili at 3177 Glendale-Milford Rd for a report. Complainant called the PD in reference to the business being broken into overnight. The suspect stole cash from the cash drawers. The business owner declined prosecution. The suspect broke a window on the south side of the building and proceeded directly to the rear office of the building. He took cash only from one of the cash drawers and a blue money bag with \$150.00 US currency. Case is under investigation.

On 2/6/2024 at 0232 hours, Officers were dispatched to a possible B/ E in progress at the Valley Thrift store located at 9840 Reading Rd. The dispatcher advised that suspect was wearing a black sweater, pants with a blue hat and carrying a black bag. Officers responded to the area. Once on scene, Officers discovered the front door of the business was shattered. Assisting agencies, Reading and Woodlawn located the suspect, walking by Central Tool at 9666 Reading Rd. The suspect's entire back was covered in shattered glass and he had a cut to his left hand. Suspect was transported to the PD and had the squad check out his hand injury. They determined he did not need any medical

care. Suspect was arrested for B/E, theft, criminal tools, and criminal damaging after he was found in close proximity to a break in at Valley Thrift. Suspect was found in possession of 87 stolen items, a mallet, and a rock. Case closed adult arrest.

THEFT

On 2/1/24 at 1520 hours, Officers were dispatched to 2801 Cunningham Drive for a report. The suspect, on multiple days, while employed by Walmart, did select various merchandise from the sales floor, concealed it, then exited the store without attempting to pay for the merchandise without the consent of the owner. Total theft \$63.54. Case closed - adult arrest.

On 2/18/24 at 1740 hours, Officers were called to Menards at 2789 Cunningham Drive for a theft. Reportee stated unknown female subiect selected various merchandise placing them into her purse, and front pockets walking past all points of sale without paying for them. (Merchandise totaling \$292.38) Employee's at Menards stated a female placed items in her purse and ran out the store. Complainant stated she chased the female as she ran out the store into the parking lot, but she was unable to catch her before she made it to a maroon Honda leaving the lot traveling south on reading Road. Suspect is believed to be involved in prior thefts at Menards on three previous incidents. Case is under investigation.

On 2/21/24 at 1514 hours, Officers were dispatched to Walmart for a theft report. Arrested selected various merchandise from the sales floor and proceeded to the U-Scan. Arrested was then observed by Walmart LP scanning some items in her cart, but not scanning all of the items, Arrested then proceeded past all points of sale until she was stopped by Walmart LP. Arrested was mirandized and admitted to the theft. Total amount of theft, \$319.41. Cited and released on scene. Case closed by adult arrest.

On 2/26/24 at 1914 hours, Officers were dispatched to Speedway at 10760 Reading Road for a theft that just occurred. Two suspects selected gift cards (total #1 \$408.22. total #2 \$500.72) and said they were going to pay cash. Once the "cash" button was hit on the register the two suspects ran out of the store without paying and got into a grey Nissan vehicle. The employee is going to follow up with the manager about video. Additionally, the employee knows their YouTube channels. Speedway will be getting video of the incident together for the investigation. Case is under investigation.

FORGERY

On 2/15/24 at 1200 hours, Officers responded to General Electric Credit Union (GECU), 10485 Reading Road for a report. The fraud investigator for GECU reports the suspect deposited a counterfeit check for \$9,830, then made a \$6,000 withdrawal of the fraudulent funds on the listed dates and times. Investigation is pending.

TRESPASSING

On 2/19/24 at 1215 hours, Officers responded to Menards reference a subject who Menards Management said they trespassed from the store last week and was in the employee breakroom loitering. Manager stated the subject was trespassed from the store the previous week because he was loitering in the store. I made contact with the subject who was seated in the breakroom looking at his phone. Menards gave him official notification in writing that he was no longer allowed in the store. Subject signed the notification and left. Case closed.

DRUGS

On 2/29/24 at 2234 hours, Officers conducted a traffic stop on a vehicle for a broken taillight and no visible license plate. The passenger was arrested in which she failed to provide true identifying information, was found to have a felony warrant, and had a \$5 bill with fine white crystalline powder.
