OUR MISSION

The members of the Evendale Police Department are committed to the principles that define democracy, including the protection of constitutional rights and equal protection under the law. We will at all times exercise the authority granted to us in an ethical, consistent and lawful manner.

DISORDERLY CONDUCT

On 6/12, officers observed suspect engage in fighting and/or turbulent behavior towards multiple people while in the lobby of Landmark Church basketball gym. The suspect became verbally aggressive towards multiple people and tried to initiate fighting. Suspect was transported to the station and cited for Disorderly Conduct. Case closed—adult arrest.

CRIMINAL DAMAGING

On 6/5, the rental manager from Mike Albert Leasing called the station due to a rental car that was returned with numerous bullet holes. When the vehicle was returned there were obvious attempts to conceal the damage to the vehicle. The driver side door had been replaced and parts of the vehicle had been painted. The renter of the vehicle was questioned about the damage but denied any knowledge of any damage. Case is under investigation.

On 6/23, officers were dispatched to Menards for a report of criminal damaging to a car. Upon arrival, the complainant stated he arrived at Menards at 11:20 AM, parked his car and went inside. When he came out about a half hour later there was a note on his car and a scratch going down the driver side of his vehicle. After watching surveillance video of the incident, no suspects or suspect vehicles were able to be identified. Case suspended inactive pending any new leads.

PASSING BAD CHECKS

On 6/11, officers were dispatched to Gold Medal Products reference a fraud. Victim stated an unknown person(s) were using Fed Ex Express to mail out paperwork/checks to individuals using the Gold Medal Products account and mailing address. The report is for information/documentation purposes. Case closed by exceptional means.

On 6/11, victim came to the station to report that while paying his car payment at GE Credit Union, an acquaintance of his father wanted him to cash a check for him. The suspect wrote a check for \$1,411.72 drawn on a Kemba Credit Union account. Victim reports he paid his car payment and then the teller cashed the check and handed the money to the suspect. The check was returned insufficient funds on June 11. An investigation is pending at this time.

THEFT

On 6/9, an employee of Pro-Clean car wash responded to the station to file a theft report. Victim reports the business received a phone call from a man claiming to be a Duke Energy associate. The man stated they were requesting payment on the business account for an overdue bill. The victim obtained 3 \$400 Money Gram prepaid cards and was to read the numbers to the phone caller/scammer. Officers tried to contact the phone number but it was clearly a phone spoof for Duke Energy. There are no other investigative leads at this time. Case has been suspended inactive.

On 6/11, officers responded to Walmart for a shoplifter being held in the asset protection office. The suspect selected merchandise from the store and went to the self check out register. Suspect paid for some merchandise but failed to pay for \$68.65 worth of children's merchandise and shoes. All merchandise was recovered after the theft. Suspect arrested and cited to Evendale Mayor's Court. Case closed by arrest.

On 6/14, officers were called to Walmart reference a shoplifter. Suspect selected various items from the sales floor and concealed them in her backpack. Suspect also placed items in her grocery cart. She failed to pay for the items concealed in her backpack and some items in her cart. Total value of theft \$387.41. Suspect charged with theft and released. Case closed by adult arrest.

On 6/25, officers were dispatched to Walmart for a theft. Suspect se-

lected various items and failed to pay for \$433.26 in merchandise. Suspect was cited and released. Case closed by arrest.

BURGLARY

On 6/29, victim contacted the station to report an aggravated burglary at her residence. According to the victim, the garage door to the residence was inadvertently left open during the overnight hours. The next morning she discovered her wallet laying on the garage floor. Upon inspecting the contents of her purse, she discovered approximately \$12 cash and her Capitol One credit card missing. Officers advised the victim the case status would remain open and the investigation into the case would be ongoing. Investigation pending.

DRUG ABUSE

On 6/10, officers conducted a traffic stop on a vehicle for operating without headlights. Upon making contact with the driver, officers smelled a strong odor of marijuana. When questioned, the driver admitted to possessing a small amount of hashish oil in his vehicle, as well as multiple paraphernalia items used to ingest the hashish oil. Subject was cited for drug abuse and possession of drug paraphernalia and released. Case closed- adult arrest.

On 6/30, officers observed a vehicle travelling at a speed of 81 MPH in a 55 MPH zone on northbound I-75. When stopped. officers found that the vehicle had illegal plates on it belonging to a different vehicle. Officers found the driver to have a baggie of marijuana in his pocket. An inventory search of the vehicle prior to being towed revealed a second baggie of marijuana in the glove box. Suspect admitted both baggies were his. Subject cited to Evendale Mayor's Court and released. Case closed by arrest—adult.
