PASSING BAD CHECKS

On 3/7/24 at 1500 hours, complainant responded to the Evendale Police department to file a report on himself for passing bad checks at the ShareFax Credit Union. One check was in the amount of \$350.00 and the other was in the amount of \$475.00. Complainant advised that the bank teller advised him that the checks were fraudulent and that he needs to come to the Evendale Police Dept. to file a Police report. Investigation pending

THEFT

On 3/11/24 at 0800 hours, Officers responded to 10470 Evendale Drive for a theft report. On 3/10/24 at approximately 2100 hours, a suspect entered the lot of Linehaul Heavy Duty at 10470 Evendale Drive. The suspect then entered a truck belonging to Boasso Global and took a tablet and electric cooler. The suspect is seen leaving the lot on foot heading south on Evendale Drive. Linehaul Heavy Duty is currently working on downloading the surveillance footage to give to police. Case is under investigation.

On 3/11/24 at 1531 hours, Officers were dispatched to 2801 Cunningham Drive for a theft that just occurred. Arrested observed by Walmart Loss Prevention officer, selecting various merchandise from the sales floor and concealing it within her personal bag. Arrested then proceeded to the cash register and purchased some items, but did not pay for the items concealed within her purse. Arrested then attempted to exit the store without paying for the concealed merchandise. Total amount of theft, \$126.84. Arrested was mirandized and admitted to the theft. Case closed by adult arrest.

On 3/13/24 at 1005 hours, Officers responded to Menards, located at 2789 Cunningham Dr, Cincinnati, Oh 45241 for a theft where the shoplifter was being detained by Menard's employees. Menards observed suspect attempt to leave the store with a camera system valued at \$571.33 without paying for it.

Suspect charged with theft and transported to HCJC. Case closed by arrest.

On 3/18/24 at 0850 hours, residents on Giverny Blvd. and Falling Waters reported an unknown person(s) removed various items from the victims vehicles parked in their driveways. The suspects were located and detectives conducted a search warrant on the suspect vehicle. Case is under investigation.

On 3/20/24 at 2108 hours, Officers were dispatched to Menards reference a possible theft that had just occurred. The suspect was last seen walking out on Cunningham Drive near Fifth Third Bank parking lot. After speaking with the complainant, it is unknown if a theft actually occurred. Unknown merchandise value. This report is for documentation only.

On 3/31/2024 at 1454 hours, Officers responded to 2801 Cunningham Drive for a theft report. Walmart Loss Prevention observed suspect conceal clothing valued at \$166.09 inside his coat. Suspect then proceeded past the last point of sale without paying for the merchandise. Subject cited and released. Case closed—adult arrest.

AGGRAVATED MENACING

On 3/2/24 at 0825 hours, Officers were dispatched to 2801 Cunningham Drive to investigate threats of violence made by a former employee. The suspect caused others to believe he would cause serious physical harm by shooting up Walmart. The case is under investigation.

VANDALISM

On 3/8/24 at 1200 hours, complainant called the station to file a report. The complainant reports that he had a roof inspection completed of his business regarding potential hail and wind damage. The inspector reported to the complainant that in his opinion, some of the damage to the roof was not caused by wind or hail but rather appeared to be caused by manual manipulation. The complainant

reports no knowledge of this reported manual manipulation. The complainant further states if such manipulation occurred it would be an act of vandalism committed by unknown person(s) at an unknown time prior to the roof inspection. There are no investigative leads and this agency is not equipped to make an independent assessment of the damage. This offense is closed and the report is completed for documentation purposes for the victim business.

LOST OR STOLEN PROPERTY

On 3/21/24 at 1330 Hours, complainant responded to the PD to report the loss of her purse. Complainant said she had lost her purse within the last hour and remembered seeing it last when she placed it on the back of her car while she was fueling her car at the Evendale Speedway. The black purse had her driver's license, social security card, Sharefax Debit Card, and \$1,600 cash inside it. She said she was able to close/cancel her debit card before anyone could use it.

CRIMINAL TRESPASS

On 3/28/24 at 1902 hours, Officers were dispatched to 2789 Cunningham Drive for a report. The suspect was located standing near the bus stop in front of Menards. Suspect started at Walmart where she selected various clothing, laundry detergent and air fresheners (total value \$212.50), concealed the items in bags she brought into the store and then went past the last point of sale without paying for the items. Suspect then went to Menards where she selected various cleaning supplies (total value \$121), concealed them in the bags, then went past the last point of sale without paying for the items. Subject admitted to stealing from Menards and Walmart. Additionally, the suspect had been trespassed from Walmart on February 12, 2024. Suspect was arrested, transported back to EPD, recited for an EPD warrant, cited for theft x2 and trespassing. Case closed—adult arrest.
