ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE A DEED TO GLENN AND TERRY ALLEN, 2935 STANWIN PLACE, SUBJECT TO CONDITIONS SPECIFIED HEREIN, AND DECLARING AN EMERGENCY

WHEREAS, Glenn and Terry Allen are the owners of property at 2935 Stanwin Place,

Parcel No. 611-0080-0167-00; and

WHEREAS, The Allen property is adjacent to 21.665 acres of land, Parcel No. 611-0080-

0206-90, owned by the Village of Evendale; and

WHEREAS, The Village of Evendale property and the Allen property are adjacent to

property owned by Christina and Jeanine M. Lang at 2899 Stanwin Place,

Parcel No. 611-0080-0192-00; and

WHEREAS, The Allens are desirous of selling their property; and

WHEREAS, When the Allens prepared to sell their property, they discovered, evidently for

the first time, that the prior owner of the property had encroached on both the Village of Evendale property and the Lang property with fences and certain

other structures; and

WHEREAS, In an effort to resolve this matter, the Allens are willing to purchase the

Village of Evendale property on which they have encroached and remove the

encroachments on the Lang property; and

WHEREAS, The Village of Evendale is willing to cooperate in such a sale provided that

certain conditions specified herein are met; and

WHEREAS, The Council of the Village of Evendale finds that the property to be

transferred is not needed for any public purpose;

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring that:

SECTION 1:

The Mayor of the Village of Evendale is hereby authorized to execute a deed to Glenn M. Allen of the land depicted on Exhibit A, attached hereto and incorporated by reference herein, designated as "A." The specific legal description of that property shall be determined by a survey and shall include that portion of the Village of Evendale property which includes the fence and the Village of Evendale property within the fence believed to have been installed by Mr. Allen's predecessor in title, provided that the following conditions are met:

- 1) There are currently three sheds located on the property to be transferred. One of the existing sheds must be removed prior to the transfer of the property;
- The property marked "B" on Exhibit A designates the encroachment on the area in which an encroachment now exists on the Lang property. The encroachment includes certain structures, including a deck and hot tub. All encroachments on the Lang property shall be removed prior to the transfer of the Village of Evendale property to Mr. Allen;

- The deed transferring the Village of Evendale property to the Allens shall be done as an ORC 711 Transfer and shall specifically prohibit that there be any further development on that property inconsistent with the Zoning Code of the Village of Evendale. The deed shall contain the following language:
 - "This conveyance is a transfer between adjoining lot owners made in compliance with Section 711.001, Subsection (B)(1), Ohio Revised Code, and does not create an additional building site or further violate any zoning regulation or other public regulation in the parcels hereby conveyed or the balance of the parcel retained by the Grantor herein. The parcel hereby conveyed may not hereafter be conveyed separately from Grantee's adjoining parcel, nor any structure erected thereon without the prior approval of the authority having approving jurisdiction of plats.";
- 4) In light of the fact that the property being conveyed is regarded as Village Greenbelt property, the deed shall also contain a covenant prohibiting any the construction of any new structures on the conveyed property including any new home or addition to the existing home.;
- 5) At closing, the Allens shall pay the Village of Evendale the cost of the survey and preparation of the legal description, \$2,500 for the property, and shall bear the cost of any and all reporting fees.

SECTION 2:

This ordinance is declared to be an emergency by a concurrence of five members of Council, being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale or to provide for the daily operation of a department or office of the Village of Evendale. WHEREAS, IBI Group on behalf of General Electric has submitted a certain set of grading plans on property it owns, specifically surrounding the 100 Building at the North end of the campus and 501 Building in the center of the campus for reconstruction of a parking areas, in accordance with Evendale Ordinance 1466 et. seq.; and

WHEREAS, the Engineer of the Village has given his approval of said plans for the property to be developed by the property owner; and,

WHEREAS, the plans approved by the Village Engineer appear to be in good order and in compliance with the purposes and intent of Evendale Ordinance 1466 et. seq.

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring that:

<u>SECTION 1:</u> The copy of the plans submitted by IBI Group on behalf of General Electric, the property owner, in accordance with Evendale Code Section 1466 and approved by the Village Engineer are hereby attached as Appendix A and made part hereof.

SECTION 2: The Council of the Village of Evendale finds that notwithstanding the requirement in Section 1466.04 of the Codified Ordinances of the Village of Evendale, that such plans be held for 30 days before action by Council public policy justification exists to proceed immediately in order to obtain the benefits of the improvements, the reduction of impervious surfaces and the enhancement of greenspace, landscaping and aesthetic appeal of GE site as soon as possible and Council further finds said plans as approved by the Engineer to be well taken and to comply with the intent and purposes of Ordinance 1466 et. seq., and are hereby approved by this Council.

SECTION 3: The approval of Council of these plans shall be conditioned upon and shall not take effect until the filing of the plans with the Building Commissioner and filing of the performance bond set by Council in the amount of \$25,000.00 for Building 501 and \$40,000.00 for Building 100. In addition, the issuance of the Water Management and Sedimentation Control Permit is conditioned up Site Plan Review and Approval by the Village Planning Commission and Building Department of the proposed plans.

<u>SECTION 4:</u> Copies of the plans as approved by Council shall also be filed with the Clerk, the Engineer, the Building Commissioner, the Planning Commission and the County Soil and Water Conservation District.

<u>SECTION 5:</u> Upon the filing of said approved plans with the Building Commissioner and upon the posting of the bond specified above, the Building Commissioner shall issue the appropriate permit to commence the work, etc. as provided by the approved plans.

<u>SECTION 6:</u> This ordinance shall not constitute approval for any building or structure.

SECTION 7: This ordinance is declared to be an emergency by a concurrence of five members of Council, being necessary to preserve the public, peace, order, safety, health or welfare of the Village of Evendale or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect because the public safety and welfare require work commence immediately to promote the renovation of the GE site and therefore the economic health of the Village of Evendale and reduce the impervious surface area and enhance landscaping of the site at the earliest possible date. This ordinance shall be effective upon passage.

SECTION 1: The Council hereby gives its consent for the Board of County Commissioners of Hamilton County, Ohio, to enter into an enterprise zone agreement with ENABLE, a draft of which is attached to this Resolution as Exhibit A.

SECTION 2: This resolution is declared to be an emergency by concurrence of five members of Council, being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect so the Board of County Commissioners may promptly proceed to enter into the Agreement with ENABLE and the benefits of such agreement be obtained as promptly as possible.
