ORDINANCE TO AMEND ORDINANCE NO. 11-23 TO EXTEND BOUNDARIES OF THE READING-LOCKLAND-ARLINGTON HEIGHTS-EVENDALE ENTERPRISE ZONE WITHIN THE VILLAGE OF EVENDALE AND DECLARING AN EMERGENCY

WHEREAS, the Ohio Enterprise Zone Act ("the Act"), under Ohio Revised Code Section 5709.61 through 5709.66, has authorized counties, with the consent and agreement of affected municipalities and townships therein, to designate areas as Enterprise Zones; and

WHEREAS, the Council of the Village of Evendale, by adopting Ordinance No. 94-23 on November 3, 1994, has designated an Enterprise Zone which encompasses Census Blocks 101, 108, 117, and 118 of the 1990 United States Census Tract 0231, and by adopting Ordinance No. 95-48 on May 4, 1995, extended the boundaries of the Enterprise Zone to include Census Blocks 113 and 114 of the 1990 United States Census Tract 0231 and by adopting Ordinance No. 97.33 on April 10, 1997, extended the boundaries of the Enterprise Zone to include Census Block 120 within 1990 United States Census Tract 0231, and by adopting Ordinance No. 11-23 on May 10, 2011, extending the boundaries of the Enterprise Zone to include Census Blocks 1010, 1011, 1012, 1016, 1017, 2018, 2019, 2020 within the 2000 United States Census Tract 0231 within the boundaries of the Village of Evendale to promote the economic welfare of said Municipality; and

WHEREAS, the Board of Commissioners of Hamilton County, by Resolution February 8, 1995, Volume 257 Image 2011, authorized a petition to the State of Ohio for the City of Reading, the Village of Lockland, and the Village of Evendale to be certified as a distressed Urban Jobs and Enterprise Zone; and

WHEREAS, the Board of Commissioners of Hamilton County, by Resolution July 12, 1995, volume 259 Image 316, authorized a petition to the State of Ohio for an amendment to said Urban Jobs and Enterprise Zone to extend the boundaries within the Village of Evendale; and

WHEREAS, the Board of Commissioners of Hamilton County, by Resolution April 16, 1997, Volume 266, Image 742, authorized a petition to the State of Ohio for an amendment to said Urban Jobs and Enterprise Zone to extend the boundaries within the Village of Evendale; and

WHEREAS, the Board of Commissioners of Hamilton County, by Resolution May 11, 2011, Volume 322, Image 3924, authorized a petition to the State of Ohio for an amendment to said Urban Jobs and Enterprise Zone to extend the boundaries within the Village of Evendale; and

WHEREAS, effective July 2, 1997, the Director of Development of the State of Ohio determined that the area designated by the Board in its Enterprise Zone Resolution contains the characteristics set forth in O.R.C. Section 5709.61 (A) and certified said area as an Enterprise Zone under said Chapter 5709; and

WHEREAS, the above-referenced Census Blocks in 1990 U.S. Census Tract 0231 are now known as Blocks 1007, 1008, 1009, 1018, 1019, 1020, 1021, 2016, 2017, 2024, 2025, 2028 and 2030 of 2000 U.S. Census Tract 231; and

WHEREAS, the Village Council upon due consideration desires to extend the boundaries of the Enterprise Zone to also include Blocks 1013, 1014, 1015, 2013, 2014, 2015, 2026, 2027, 2029 of 2000 United States Census Tract 0231; and

WHEREAS, it is necessary for the Council for formally request from the Board of County Commissioners of Hamilton County, Ohio, the inclusion of areas of the municipality within an Enterprise Zone and to include such resolution in a petition to the Directory of Development of the State of Ohio to certify the area described as such a zone; now,

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF **EVENDALE, STATE OF OHIO, six members concurring, that:**

SECTION 1: The Village Council hereby amends Council Ordinance No. 11-23 to include Blocks 013, 1014, 1015, 2013, 2014, 2015, 2026, 2027, 2029 within 2000 United States Census Tract 231, and amends Exhibit A of that ordinance to reflect this change.

SECTION 2: The Clerk of the Board of County Commissioners, of Hamilton County, Ohio, is hereby authorized to amend and resubmit its petition to the Director of Development of the State of Ohio to incorporate this change in boundaries of the Reading-Lockland-Evendale Enterprise
