AN ORDINANCE APPROVING A TRANSFER FROM THE GENERAL FUND TO THE MUNICIPAL MOTOR VEHICLE FUND TO RESURFACE PLAINFIELD ROAD AND DECLARING AN EMERGENCY

- **WHEREAS,** pursuant to legislation properly adopted by the Council of the Village of Evendale, certain expenditures will take place that need to be appropriately reflected as an appropriation; and,
- **WHEREAS,** the City of Blue Ash is going to resurface Plainfield Road and has requested Village participation in the project for our portion of the road; and
- **WHEREAS,** it is more efficient to work in conjunction with our neighbors and will be a cost savings to the Village in the long term; and
- **WHEREAS,** Evendale has agreed with Blue Ash to expend up to Thirty Thousand Dollars (\$30,000.00) as Evendale's share of the project pursuant to Ordinance #16-10; now

AN ORDINANCE AUTHORIZING THE PAYMENT OF AMOUNTS DUE UPON CERTAIN CONTRACTS REQUIRING CERTIFICATION OF AVAILABILTY OF FUNDS AND DECLARING AN EMERGENCY

- WHEREAS, Ohio Revised Code 5705.41(D)(1) provides that where contracts have not been previously certified for sufficient funds being available, Village Council may authorize the drawing of warrants to pay such contracts upon receipt of a certificate from the fiscal officer stating that there was at the time of the making of such contract or order and at the time of the execution of such certificate, a sufficient sum appropriated for the purpose of such contract and in the treasury or in the process of collection to the credit of an appropriate fund free from any previous encumbrances, and
- **WHEREAS,** Certain contracts enumerated below are now due and payable for which such a certificate has been provided by the Chief Fiscal and Accounting Officer;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring, that:

SECTION I The Council of the Village of Evendale hereby approves and authorizes the payment of the following contracts for which the Chief Fiscal and Accounting Officer has provided a certificate that a sufficient sum has been appropriated for the purpose of each contract and is in the treasury or in the process of collection to the credit of the appropriate fund free from any previous encumbrances:

ORDINANCE APPROVING A TRANSFER FROM THE GENERAL FUND TO THE OPERATIONS AND MAINTENANCE ACCOUNT IN THE FIRE DEPARTMENT AND DECLARING AN EMERGENCY.

WHEREAS,	The annual Fire policy manual update was billed in full by Lexipol rather than at the discounted amount as was done in the past; and
WHEREAS,	Lexipol is going to send a rebate directly to the Village which must be deposited in the General Fund; and
WHEREAS,	The Fire Department has paid the total bill. As a result, the Fire Department Operations and Maintenance Account will be left short for the year since the discount was expected to be included in the invoice; and

AN ORDINANCE AUTHORIZING THE MAYOR TO HIRE A CURRENT PART-TIME EMPLOYEE IN AN ADDITIONAL PART-TIME CAPACITY AND SETTING A PAY RATE AND DECLARING AN EMERGENCY

WHEREAS,	The Council of the Village of Evendale enacted Chapter 260 of the Codified Ordinances of the Village of Evendale by passing Ordinance #15-65 hiring Tara Bain as a Childcare Attendant, through the year ending December 31, 2016, at \$9.60 per hour: and

- WHEREAS, The Mayor has recommended Tara Bain to be employed or reemployed, on a part-time basis for the year ending December 31, 2016, in an additional capacity, with the Recreation Department, as a Clerk; and
- WHEREAS, The Mayor has fully complied with Section 260.06(a) of the Codified Ordinances of Evendale and recommended that Council authorize the hiring of Tara Bain for the part-time position for which employment is authorized by this ordinance; and

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring, that:

<u>SECTION 1</u> Tara Bain may be employed during the year ending December 31, 2016, by the Mayor of the Village of Evendale as a part-time employee as both a Clerk and Child Care Attendant at the hourly rate established by this Ordinance.

- <u>SECTION 2</u> Tara Bain's total hours worked in both capacities shall not exceed her status as a part time employee.
- SECTION 3 This ordinance is hereby declared to be an emergency measure by a concurrence of five members of Council. The ordinance is an emergency necessary to preserve the health, safety and general welfare of the Village of Evendale or to provide for the daily operation of a department or office of the Village. It is necessary that this measure be put into immediate effect because the public welfare required that this position be filled on the effective dates specified in order to meet the needs of the Recreation Department and Tara Bain should be pain on the regular schedule for Village employees. This Ordinance shall be effective upon passage and Tara Bain is approved for pay at the rate established by this Ordinance retroactive to March 16, 2016.

ORDINANCE ESTABLISHING THE POSITION OF RECREATION DEPARTMENT CUSTODIAN, MANDY INGRAM AS FULL TIME AND DECLARING AN EMERGENCY

- **WHEREAS**, The position of Recreation Department Custodian had been full time until the retirement of the person holding that position occurred; and
- **WHEREAS**, The Recreation Department was using two part time personnel to provide the custodial services to the Recreation Center; and
- **WHEREAS**, The Recreation Department would like to benefit from the efficiency of having that position be staffed consistently with one full time staff rather than two part time staff; and
- WHEREAS, This change will not require a budget adjustment for the Recreation Department as funding is available in the current budget to make the adjustment from part time to full time as there will also be a concurrent part time staff reduction in said position from two part time to one full time; and
- WHEREAS, As the employee is not a new hire nor is the position a new position, further compliance with Chapter 258 of the Codified Ordinances of the Village of Evendale regarding the hiring of new employees is not necessary, nor is a probationary period appropriate; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring, that:

<u>SECTION 1</u>	The following position is hereby designated as a full-time position during which the incumbent shall work 37.5 hours per week to be specifically determined by the Mayor in consultation with the Recreation department head. The pay rate shall be fixed below:

	The incumbent in this position shall be entitled to the same benefits as all other full-time Village employees.	
SECTION 2	Mandy Ingram's position as a full time employee shall begin on May 16, 2016.	
<u>SECTION 3</u>	This ordinance is declared to be an emergency measure by a concurrence of five members of Village Council. The reason for said emergency is to promote the health, safety and general welfare of the Village and the daily operation of the Recreation Department. It is necessary that this be an emergency measure in order to provide adequate time to complete prehiring work including a physical and afford Mandy Ingram time to give notice to her other employer, all in order to meet the start date of May 16, 2016. Therefore this Ordinance shall become effective immediately.

AN ORDINANCE AUTHORIZING THE MAYOR TO DETERMINE AND IMPLEMENT THOSE STEPS NECESSARY TO SELL THE PROPERTY LOCATED AT 3680 GLENDALE MILFORD ROAD, SPECIFICALLY HAMILTON COUNTY PROPERTY BOOK 611, PAGE 10, PARCEL 24 AND DECLARING AN EMERGENCY

- WHEREAS, the Village of Evendale is the owner of three parcels of land: Book 611, Page 10 Parcels 23, 24 and 157, said parcels being previously owned by the Cincinnati Nature Center and prior to that by Ruth P. and Stanley W. Trosset; and,
- **WHEREAS,** on two of those parcels, 23 and 157, the Trossets placed substantial restrictions in order to create and preserve a wildflower sanctuary, and on those parcels, the ability of the Village of Evendale to transfer the property is limited to the Hamilton County Park District or other governmental or charitable organizations willing to agree to the restrictions ; and
- **WHEREAS,** a house exists on Parcel 24 and the restrictions applicable to the other two parcels do not apply to Parcel 24. It may therefore be sold to anyone; and
- **WHEREAS,** said house has been vacant for some time and the Village has determined it is no longer necessary for any governmental purposes and that the lot and house would be better placed back into the single-family use for which the house was originally built and the parcel designed; now

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, five members concurring, that:

- **SECTION 1:** The Mayor is hereby authorized and directed to determine and take those steps necessary to sell the property identified in the property records of Hamilton County in Book 611, Page 10, Parcel 24. The Mayor shall evaluate the best method of selling the property, including the possibility of transferring the property to the Evendale Community Improvement Corporation or directly selling the property as provided for in Chapter 721 of the Ohio Revised Code.
- **SECTION 2:** This ordinance is declared to be an emergency measure by a concurrence of five members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. The reason for said emergency is the desire to see that the house on the property is brought up to code and put back into use as a single-family home as soon as possible, or alternatively, it is demolished and a new single-family home is built on the property as soon as possible. Therefore, this ordinance shall become effective immediately.
