# VILLAGE OF EVENDALE, OHIO ORDINANCE # 23-15

AN ORDINANCE DESIGNATING JP MORGAN CHASE BANK AS A DEPOSITORY FOR ACTIVE/INTERIM FUNDS AND RED TREE INVESTMENTS/US BANK/STAR OHIO AS A DEPOSITORY FOR INACTIVE/INTERIM FUNDS FOR THE VILLAGE OF EVENDALE FOR THE PERIOD OF FIVE YEARS FROM JUNE 1, 2024 AND ENDING MAY 30, 2029 AND AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT AND DECLARING AN EMERGENCY

WHEREAS, deposit requirements for public moneys are set out in Section 135.12 of

the Ohio Revised Code; and,

WHEREAS, those Sections permit the Village to designate the public depositories of

the Village; and,

WHEREAS, the Village adopted Resolution # 23-01 to comply with the Ohio Uniform

Depository Act, and undertook a period of advertising and notice as is required by the Act, advertising a newspaper of general circulation for two

consecutive weeks: and,

WHEREAS, Village Council deems it in the best interest of the Village to authorize the

Mayor to enter into an agreement with JP Morgan Chase Bank and Red

Tree Investments; now, therefore,

# BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

**SECTION 1:** JP Morgan Chase Bank is hereby designated as a depository of the active and interim funds of the Village of Evendale, Ohio for a period of five years commencing on June 1 2024, and ending on May 30, 2029.

**SECTION 2:** Red Tree Investments/US Bank/Star OHIO is hereby designated as a depository of the inactive and interim funds of the Village of Evendale, Ohio for a period of five years commencing on June 1, 2024, and ending on May 30, 2029.

**SECTION 3:** The Chief Fiscal & Accounting Officer is hereby authorized to agree to the pooling of the securities with those institutions that meet the criteria as set forth in Section 135.18 and 135.19 of the Ohio Revised Code.

SECTION 4: The Chief Fiscal & Accounting Officer is hereby authorized to notify the Council of the Village of Evendale and recommend a different designated depository for the remainder of the designated five year period commencing on June 1 2024, and ending on May 30, 2029 should either institution or its successors, become insolvent or operate in an unsound or unsafe manner as described in Section 135.12 of the Ohio Revised Code.

SECTION 5: The Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council: and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

SECTION 6: This ordinance is hereby declared to be an emergency by a concurrence of six members of Council, being necessary to preserve the public peace, order, safety, health and welfare of the Village of Evendale and its residents or to provide for the daily operation of a department or office of the Village. The reason for said emergency is the need to approve this ordinance in the time required by the Ohio Revised Code and to make this designation as soon as

possible in order to invest the Village's funds.	Therefore, this Ordinance shall therefore take
effect immediately upon adoption.

## VILLAGE OF EVENDALE, OHIO ORDINANCE #23-22

AN ORDINANCE APPROVING A TRANSFER FROM THE CONTINGENCY FUND TO THE GORMAN HERITAGE FARM FUND AND APPROVING AN ADDITIONAL APPROPRIATION TO THE GORMAN FARM CAPITAL ACCOUNT AND DECLARING AN EMERGENCY

WHEREAS,	Pursuant to legislation properly adopted by the Council of the Village of
	Evendale, certain expenditures will take place that need to be appropriately
	reflected as an appropriation; and,

WHEREAS, The tractor and truck currently used at the farm have well exceeded their life expectancies with excessive hours and mileage recorded; and

WHEREAS, The Village of Evendale is required by the 2015 Contract with Gorman Heritage Farm to replace inoperable equipment on the Minimum Equipment List (Exhibit C) for purposes of performing the required work of the farm; and

WHEREAS, The Gorman Heritage Farm received approval to purchase necessary equipment to perform the required duties of the farm; and

WHEREAS, Funds are required to supplement the capital expense line item in order to pay for the equipment; and

WHEREAS, Funding is available in the contingency line item to supplement the funds necessary; now

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

**SECTION 1:** The following sum is transferred from the General Fund Contingency Fund account:

101.799.579900 Transfer Out \$ 75,000.00

To the 210 Gorman Farm Fund:

210.000.499999 Transfer in \$75,000.00

And the following sum is appropriated from the unappropriated Gorman Farm Fund (210) to the following line:

210.499.525200 Capital Improvements \$75,000.00

**SECTION 2:** These appropriated funds are authorized to be expended for the purchase of a Tractor and a Truck.

This ordinance is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary

that this measure be put into immediate effect because the public welfare and daily operations of the Village require that line items within Fund budgets not exceed the appropriation amounts approved by Council and it is in the public interest to provide funding for farm equipment as soon as possible in order to maintain the operations of Gorman Heritage Farm. This ordinance shall be effective upon passage.

# AN ORDINANCE APPROVING A TRANSFER FROM THE CONTINGENCY FUND TO THE COMMUNITY ENVIRONMENT DEPARTMENT AND DECLARING AN EMERGENCY

WHEREAS, Pursuant to legislation properly adopted by the Council of the Village of Evendale, certain expenditures will take place that need to be appropriately reflected as an appropriation; and,

WHEREAS, Tri-State Trails is in process of doing a feasibility study to create a trail along the Sharon Creek from Evendale up through Sharonville to the Sharonville park; and

WHEREAS, The individual communities along the creek are asked to contribute to the study as the project will improve property value along the creek area both financially and to the community health and wellbeing; and

WHEREAS, The Village received a grant from Hamilton County Public Health for \$7,500 which will be used to defray the cost of the Village contribution and related printing costs; and

WHEREAS, Funds are required to supplement the Millcreek Interim Funding expense line in order to pay for the cost which was not previously budgeted; and

**WHEREAS,** Funding is available in the contingency line item to supplement the funds necessary; now

BE IT THEREFORE ORDAINED BY THE COUNCIL OF THE VILLAGE OF EVENDALE, STATE OF OHIO, six members concurring, that:

**SECTION 1:** The following sum is transferred from the General Fund Contingency Fund account:

101.799.579900 \$ 20,000.00

To the 499 Community Environment:

101.499.523422 Millcreek Interim Funding \$ 20,000.00

These appropriated funds are authorized to be expended for feasibility study of trails along the Sharon Creek.

This ordinance is declared to be an emergency measure by a concurrence of six members of Council, it being necessary to preserve the public peace, order, safety, health or welfare of the Village of Evendale, or to provide for the daily operation of a department or office of the Village of Evendale. It is necessary that this measure be put into immediate effect because the public welfare and daily operations of the Village require that line items within Fund budgets not exceed the appropriation amounts approved by Council and it is in the public interest to have walking trails along the creek which will enhance property value in the Village.
